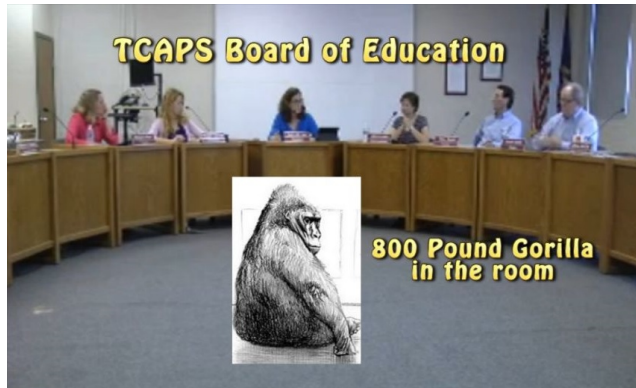

Just call him "Bob."

"I just tell them to call me Bob, B-O-B, the same backward and forward," said **Bob Fernandez**, who works one day a week in **Leelanau County** helping youths cope with issues that get in the way of academics.

Fernandez, a social worker **employed by Third Level Crisis Intervention Center**, spends Friday mornings at **Northport Public School** and then visits **Glen Lake** in the afternoon. The rest of the week, he's at **East Middle School** and the **alternative high school** in Traverse City, and the Youth Health and Wellness Center at the **Career Tech Center in Traverse City**. His service is supported through a federal homeless grant and additional money distributed through Northern Michigan Substance Abuse Services. He works closely with **counselor Meredith Schmidt at Northport** and **Glen Lake's Barb Attwood**, who refer students who are noticeably having difficulty concentrating academically.

Another issue Fernandez has to deal with — nearly on a daily basis — is **electronic bullying**.

"There's a zero tolerance for **bullying** at all schools," he said, adding that greater emphasis has been put on these activities since the recent rash of school shootings in the United States. "**Bullying** is huge, particularly at the middle school level."

BULLY (2012)

Marred by Politically Correct Sodomy

[Given a “negative 2” rating for content (out of a “plus 4” highest rating system)]



- ... Marred by **politically correct pro-homosexual content** regarding a **teenage girl who thinks she's a lesbian**, along with some young lesbian friends;

It's ironic that Mr. Watson was leading this class during “Antibullying Week”, yet he himself used the term “homophobic” numerous times to describe me, even though the very term was promoted by Harvard graduate homosexual marketing experts Kirk and Madsen in their book “After the Ball” – designed to “intentionally ... ridicule our enemies.”

Quote from the Homosexual Activists Manual:

“After the Ball: How America will conquer its fear & hatred of Gays in the 90’s”

(Pages xxiv and xxv)

“Homophobia or homo-hatred? Does it make a difference?”

“‘Homophobia’ is a comforting word, isn’t it? It suggests that our enemies, all who oppose, threaten, and persecute us ... are actually scared of us! If we must be hated, it’s comforting to imagine that we have, at the very least, the power to inspire fear. The very term ‘phobia’ ridicules our enemies (and intentionally so), evoking images many would find comical, such as the old lady standing on the dining-room table, hiking up her skirts, and shrieking – at a mere mouse.”

“... The plain English has the advantage of being blunt. Homohatred it is ...”

“From now on, therefore, when we really do mean ‘fear of homosexuals,’ ‘homophobia’ it will be; when we’re talking about hatred of homosexuals, we’ll speak (without the hyphen) of ‘homohatred,’ ‘homohating,’ and ‘homohaters’. We urge the reader to follow suit.”

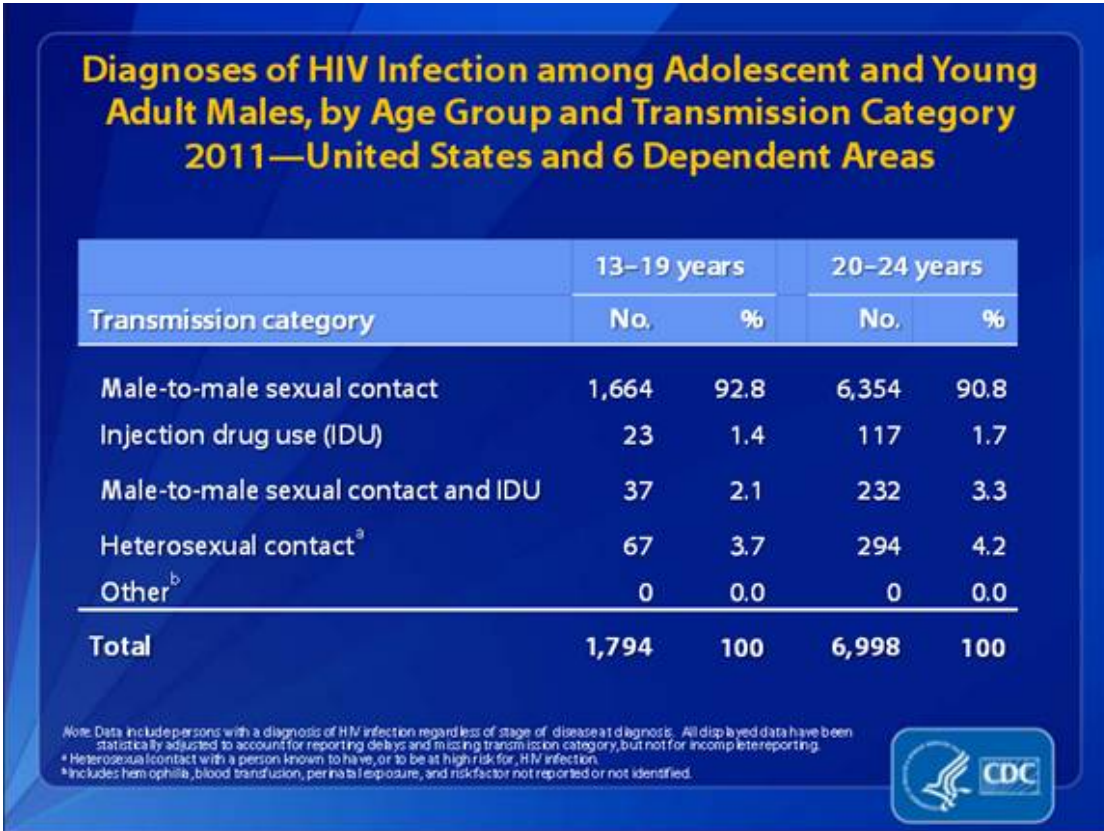

The EXTREME HEALTH RISKS and financial costs of homosexual behavior.

- The **Health Risks** are tremendous. In 2011, the **2.5 or so percent of Male Homosexuals** in the **13 – 24 year old age group** produced **95% of the new HIV Infections**.
- **Michigan** had 275 new HIV cases in 2011. Based on population only, 7 of those cases should have been from homosexuals; but instead it was **262**.
- **Based on population alone, the Traverse City Metropolitan Area (143,000 people)** should have had **4** of these new HIV cases in 2011 -- 4 new cases per year.

- The Cost of treating HIV-AIDS over a lifetime is over \$500,000 for each person infected.
- We wonder if those promoting this behavior in our community, like **TCAPS, SEEDS, Third Level, Building Bridges with Music, the Traverse City Commission, and TCEquity** will start fund raisers to **share EQUALLY the RESPONSIBILITY** of paying this new **2 million dollar annual cost** in our community.

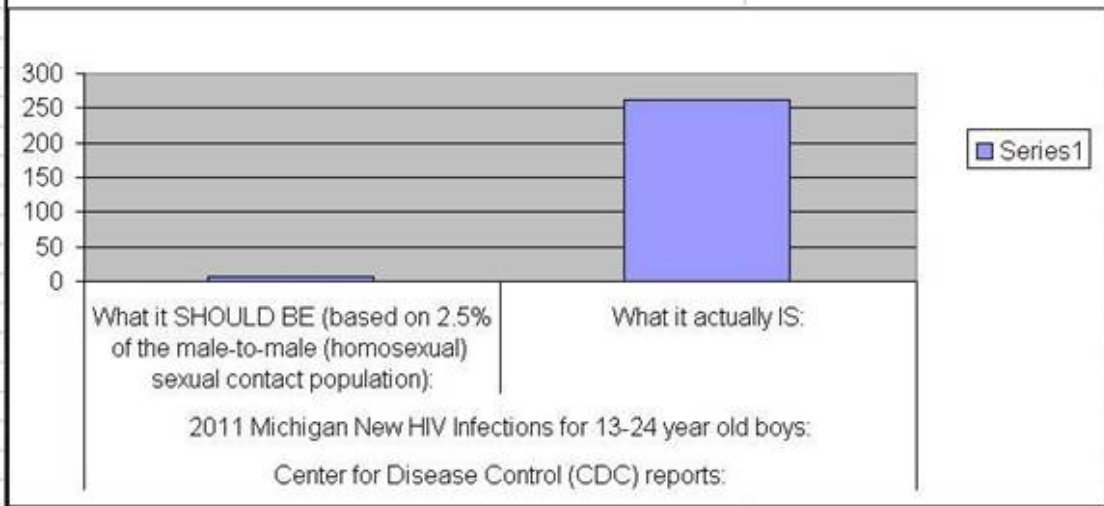

Life with HIV Costs \$618,900

Modern HIV Treatment Offers 24 Extra Years of Life -- At \$2,100 per Month

Nov. 2, 2006 - People with HIV can get 24 extra years of life from modern treatments -- at a **total cost of \$618,900** in 2004 dollars.

That finding comes from a **Cornell/Johns Hopkins/Harvard/Boston University research team** that analyzed the costs and benefits of modern HIV treatment.

... When treatment does begin, the **average monthly cost** is about **\$2,100**. The cost of drugs is nearly three-fourths of the lifetime expense.

Unfortunately, **one in four people with HIV don't know they're infected**. They find out only when their immune system collapses.

The **cost of treatment started at this late stage** averages **\$4,700 per month**. That's because hospital costs rise to almost half the lifetime expense.

... **Future costs**, Schackman and colleagues estimate, will be **\$12.1 billion per year**. Drugs will make up 70% of the cost.

Being 15 can be hard enough. What if you're 15 and think you might be gay? Windfire members describe feeling afraid that they are the only gay person in their school, that no one could possible understand them, that no one will accept them. For over 10 years, Third Level, through Windfire, has offered peer support to young people who are exploring their sexuality. Some of these youth are in the process of coming out to family and friends, some have already come out and are working to establish friends and relationships, others are just checking out their feelings for the first time and figuring out what's right for them. In some cases, Windfire is the first time they've met other LGBTQ (lesbian, gay, bi-sexual, or trans gendered, questioning) youth. In many cases, it's the first time they've talked with anyone openly about sexual feelings and other life issues.

Windfire offers a place where young people let their guard down and be themselves.

Street Outreach also provides supervised recreational activities during the summer in addition to a variety of events throughout the year. This program also runs a **youth Drop-In. At Drop-In youth can participate in therapy groups that assist youth in exploring strengths, identify goals, healthy eating classes, physical education and relationship building.** Youth can also participate in the planning and implementing of outreach activities for community youth while **receiving trainings to become a peer leader in their community, Peer Outreach Worker.** For more information call Third Level's Street Outreach Program. 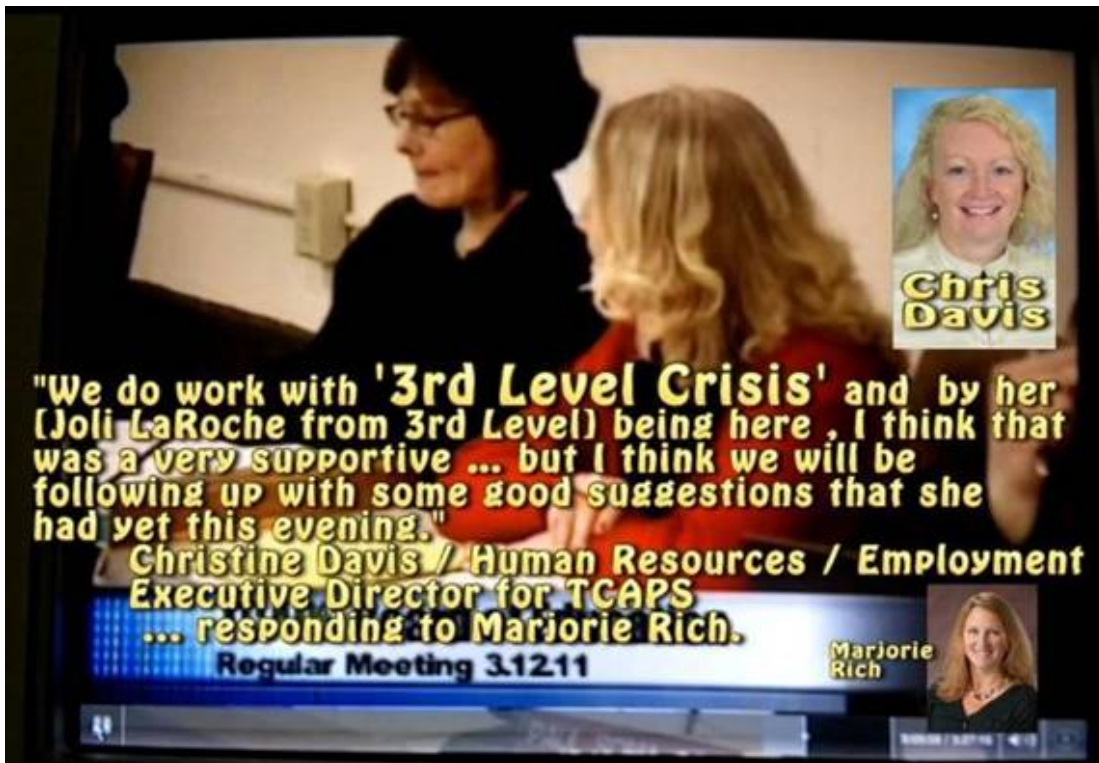

Bullies beware: Change is here

... TCAPS administrators worked for more than a year to implement **The Olweus Bullying Prevention Program**. The program takes a **holistic approach** to tackling bullying by involving **students, teachers and community members**.

... “We are really seeking to **get those bystanders involved** and be more proactive in reporting it, and the staff in dealing with it,” said **Ryan Ranger**, assistant principal at **Traverse City West Middle School**.

... “If we can -- through training and improving peer relationships -- **develop a culture that’s more positive**, not only will we reduce incidents of bullying, but we can stop them before they start,” said **Jason Jeffrey**, assistant superintendent for general and career & technical education at TBAISD.

... **The Olweus program** aims to fix those and other low-supervision situations by **training bus drivers, cafeteria workers and other non-teaching staff** how to recognize and confront bullying situations.

... “**The program isn’t going to fix bullies**,” said Traverse City Central High School assistant principal **Jay Lerner**. “The intent of the program is to **empower the 90 percent of students** who are not generally engaged in any sort of bullying act so they can support the 10 percent who are.”

The Olweus Bullying Prevention Program website – excerpts:

Bullying Based on Perceptions about **Sexual Orientation**

- As many as 93 percent of teenagers hear derogatory words about **sexual orientation** at least once in a while ...
- Negative name-calling and **harassment about sexual orientation** can be harmful to all students.

Negative Impact of Bullying

- Bullying and harassment can have negative effects on the development and mental health of **GLBTO students** ...

- **GLBTO students** are also at risk for not getting the support they need when they are being bullied ...

About Sexual Orientation

- It is estimated that approximately **5 to 9 percent of youth are gay or lesbian, bisexual, or uncertain about their sexual orientation**.
- The American Psychiatric Association and the American Psychological Association changed their stance on **homosexuality** in the 1970s, stating that it is not a disorder and that **sexual orientation** is not a person’s individual choice, nor can mental health professionals “change” the **sexual orientation** of their clients.

Adult Responses Are Important!

- ... Consult with a **school counselor or other mental health professional** if you feel uncertain about how best to support a student.
- Support training and education for **staff** about these issues.

We at TCFamily.org agree with should stop all bullying; yet risky and immoral homosexual behavior should not be promoted to our children; instead, it should be discouraged to all TCAPS children Kindergarten – 12th grade.

Therefore TCFamily hands out the PFOX “Preventing Bullying At Your School” handout to help stop bullying without promoting homosexual behavior.

What creates a bullying situation?

- Negative or malicious behaviour
- Repeated over a period of time
- In which there is an imbalance in strength or power between the bully and victim

Why do bullies bully?

They have a marked need to dominate and suppress other students, to assert themselves by means of force and threats, and to get their own way. Some bully because they themselves were bullied and find strength in exerting power over others. Some bullies are popular, others are not. The popularity of the bully lessens at the higher class/grade levels.

Bullying defined: Bullying is intentionally exposing another person to verbal or physical harm, or harming or threatening to harm another person's property. The harm is sufficiently severe, persistent, or pervasive that it creates a threatening or abusive educational environment for a student.

Bullying policies should provide protection for all students, and not single out certain students. Some bullying policies contain a list of student characteristics, such as "sexual orientation," which labels students and encourages others to do so. Such lists are unnecessary and restrictive because anyone can be bullied for any reason.

Anti-bullying policies and harassment laws do not need to list student characterizations in order to protect all students. Policies and laws should provide protection for all students without reference to groups or classifications of victims. Every child who is bullied has the special right not to be bullied.

Why is it wrong to use name calling like "gay" or "queer"?

Derogatory name calling is a form of bullying.

"The teasing of others who called me derogatory names such as 'fag,' 'queer,' and 'dyke' caused me to begin believing the lies they were telling me." -- Marjorie

"As a questioning teen, I was told that I was 'gay' and my classmates ridiculed me. Later as an adult, I discovered that change is possible. So now I'm called names as an ex-gay. Everyone should be treated with respect regardless of their sexual orientation." -- Charlie

Many people, especially during adolescence, are called "gay" or other names even though they do not have same-sex attractions.

Appearance is not a reliable means to know what another person feels.

No one should be labelled "gay," "sissy" or "queer" based on the perception of others. They may begin to believe what others tell them about themselves, which may be completely false labelling and cause gender confusion for the victim.

Moreover, a number of teens who do have same-sex attractions choose not to be identified based on who they are attracted to. Others are working to overcome their unwanted same-sex attractions and should not be called "homophobic," "pretender," or "fake" -- derogatory words often used to describe ex-gays. Such name-calling can lead to depression, fear and feeling unsafe.

Students who have transitioned out of a homosexual identity, or decide to pursue alternatives to homosexuality, deserve compassion and respect. Their decision should not subject them to discrimination, ridicule, fear or hate.

According to the American Psychological Association, scientists don't know exactly what causes homosexual attractions. (2008) The American Psychiatric Association states that there are "no replicated scientific studies supporting any specific biological etiology [cause] for homosexuality." (2000) Rather, the evidence points to an interaction of cognitive and environmental factors. Name calling and stereotyping create a negative environment.

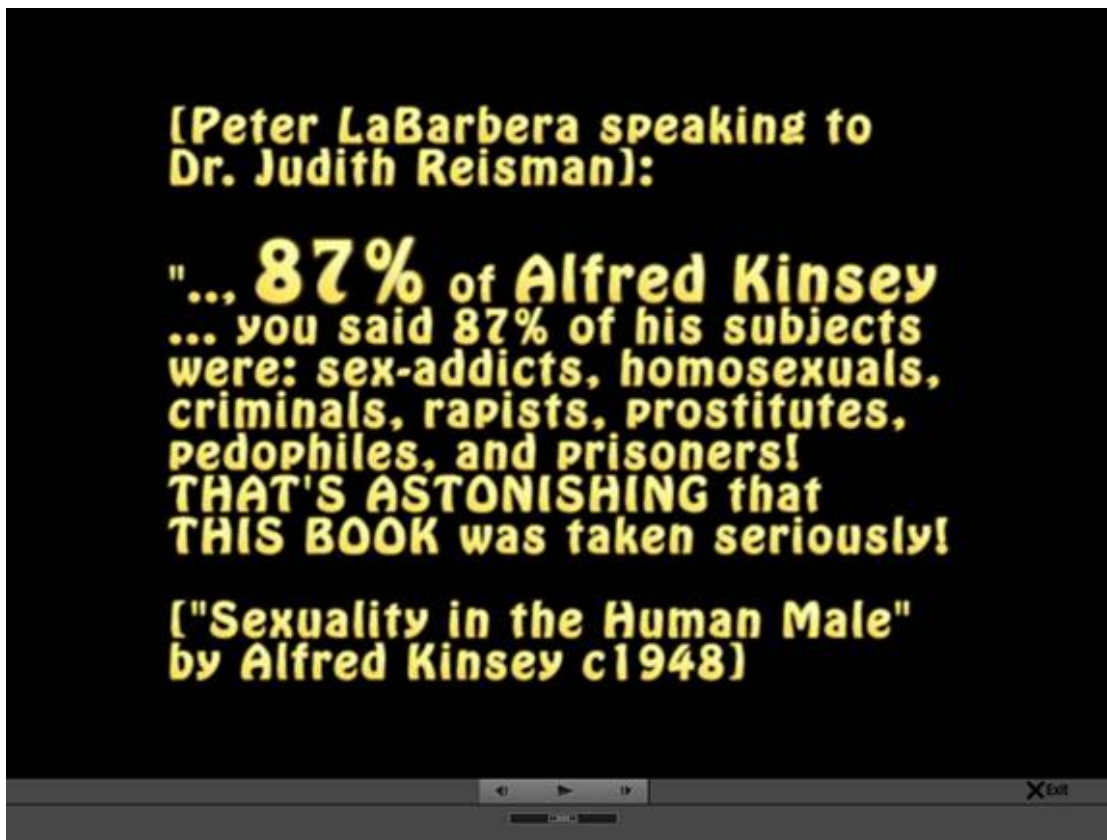

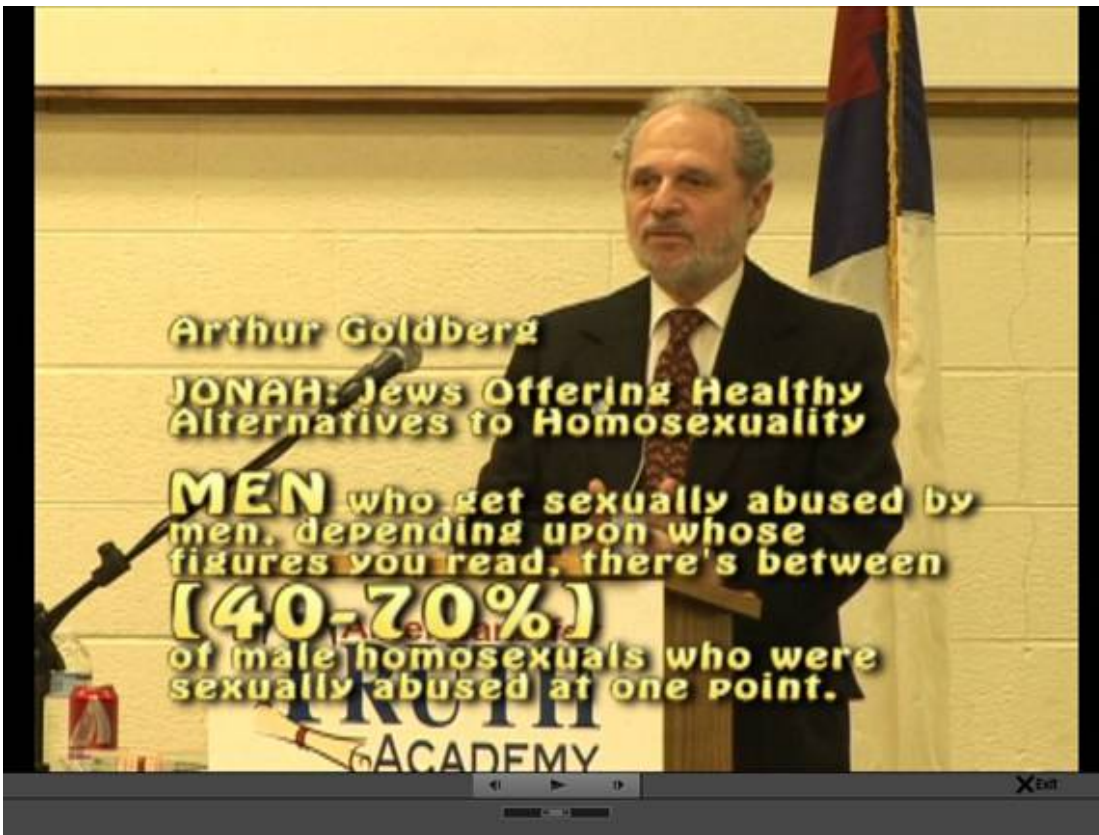

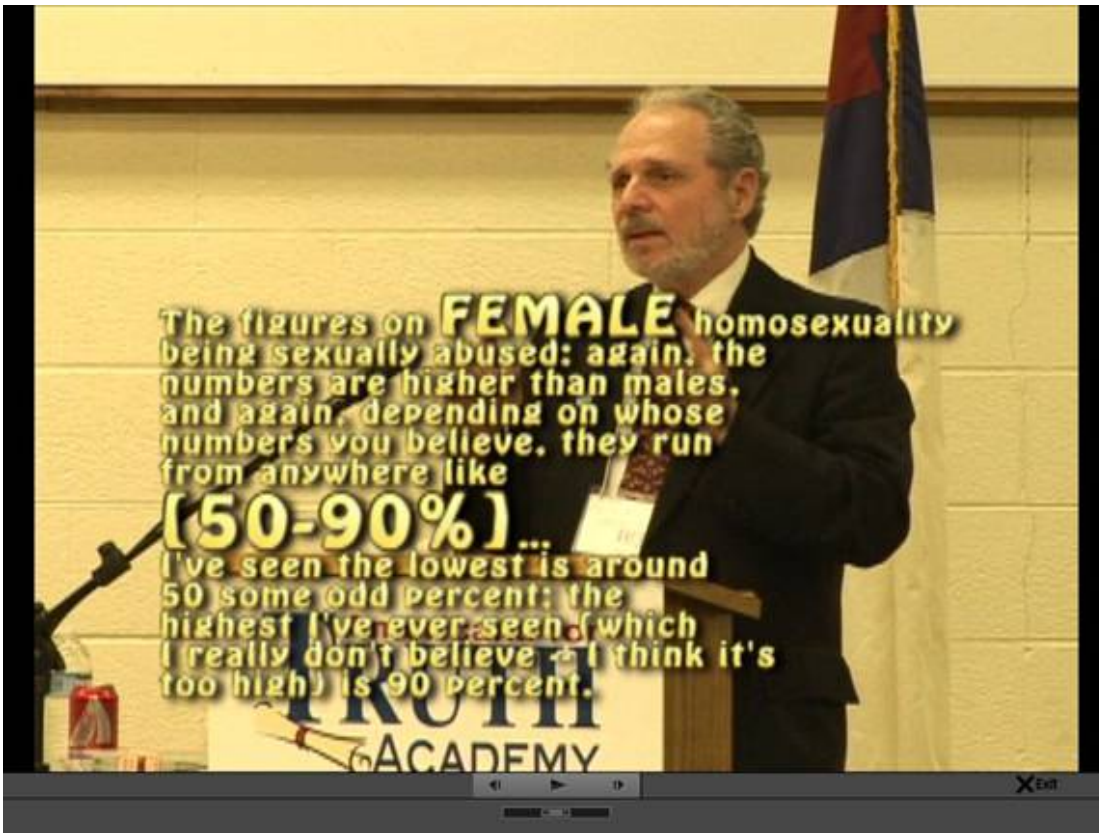

PAGE 1 of 3 -- Intimidating the APA

"It was never a medical decision—and that's why I think the action came so fast... It was a political move." "That's how far we've come in ten years. Now we even have the American Psychiatric Association running scared." (Barbara Gittings, Pro-Sodomy Activist)

Prior to December 14, 1973, the American Psychiatric Association (APA) considered same-sex attraction a disorder. The disorder was listed in the *Diagnostic and Statistical Manual of Mental Disorders-II (DSM-II)* under the label, "Homosexuality."

... "Scientific opinion" was crucial in the public attitude.

Activist Franklin Kameny states the movement's objective clearly, "I feel that the entire homophile movement... is going to stand or fall upon the question of whether or not homosexuality is a sickness, and upon our taking a firm stand on it..." [1]

Led by radicals like Franklin Kameny, pro-sodomy activists attacked psychiatrists across America, as *Newsweek* describes:

"But even more than the government, it is the psychiatrists who have experienced the full rage of the homosexual activists.

... A group of 30 militants broke into a meeting of the American Psychiatric Association in Washington, where they turned the staid proceedings into near chaos for twenty minutes. 'We are here to denounce your authority to call us sick or mentally disordered,' shouted the group's leader, Dr. Franklin Kameny, while the 2,000 shocked psychiatrists looked on in disbelief. 'For us, as homosexuals, your profession is the enemy incarnate. We demand that psychiatrists treat us as human beings, not as patients to be cured!'" [2] Ironically, at the very moment Franklin Kameny was claiming that sodomy was healthy, safe, and natural a deadly virus was silently passing through communities of men all over the nation. Only a decade later, thousands of men would be dead or dying of AIDS.

On June 7, 1971, Franklin Kameny wrote a letter to the *Psychiatric News* threatening the APA with not only more, but worse, disruptions. In this letter he states, "Our presence there was only the beginning of an increasingly intensive campaign by homosexuals to change the approach of psychiatry toward homosexuality or, failing that, to discredit psychiatry." [3]

Barbara Gittings [homosexual activist working to change the APA] said: ... Psychiatrists were one of the three major groups that had their hands on us. ... Religion and law were the other two groups ... So, besides being sick, we were sinful and criminal. ...

Gittings took place in disruptive "zap" attacks on the APA. ... "The 1970 convention in San Francisco was disrupted by a group of feminists and gay men ...

The "Gay" Militants, a book about that time, adds details, "On May 14, 1970 psychiatrists became the hunted. ... By the time the meeting was over, the feminists and their gay cohorts were in charge ... and the doctors were heckling from the audience." [8] Pro-sodomy activists took over the podium and microphones. ... With two papers still unread, the chairman announced a adjournment."

The Advocate reported on other disruptions: "PSYCHOLOGISTS GET GAY LIB THERAPY."

On June 23, 1970, activists disrupted another meeting of the American Psychiatric Association. This time in Chicago, they repeatedly shouted down the main speakers discourse [11] Again, in October, during a meeting at the University of Southern California, pro-sodomy activists shouted down a speaker and took over the stage and microphone [12]

Pro-sodomy activists continued to pressure the APA through 1973. ...

While activists were terrorizing psychiatrists, the APA's Board of Trustees was being stacked with members sympathetic to persons with SSA. ...

"In the APA elections of 1972 and 1973 concern over social issues brought in a number of individuals as members of the Board of Trustees who were committed to change, including removal of homosexuality per se from the official APA nomenclature." [14]

Dr. Robert L. Spitzer M.D. ... was one of the psychiatrists committed to change. During this time Dr. Spitzer

organized a symposium which took place at the APA annual meeting in Hawaii and included pro-sodomy political activists. ...

Dr. Brill then assigned Dr. Spitzer the assignment of preparing a "scientifically sound" and "persuasive" resolution and memo to be presented to the APA's Council on Research and Development,

On December 15, 1973 the Board of Trustees of the American Psychiatric Association capitulated to the demands of the radicals and adopted Spitzer's resolution. "The pro-sodomy activists had begun to speak of unyielding psychiatrists as "war criminals," [16]

In December of 1973 pro-sodomy journalist Andrew Sullivan wrote that the APA, "... under intense political pressure ... removed homosexuality from its official list of psychiatric disorders..." [17] ...

Many members of the APA were outraged at the Board for caving in, and changing psychiatry as a result of political pressure. They called for a full vote by the APA's 17,905 members [19] ... Only slightly less than one-third of the APA's membership approved the change. It should be further noted that

the vote was partially controlled by the "National Gay and Lesbian Task Force" (NGTLF). The "NGTLF" was able to obtain APA member addresses and with-out identifying itself as an organization send out letters to all members urging them to vote to remove "homosexuality" from the DSM. Bruce Voeller, the head of the "NGTLF" admits, "Our costly letter has perhaps made the difference." [20] ...

But was this vote a scientific decision, or was it a political one? Pro-sodomy historian Enrique Rueda writes, "This vote was not the result of scientific analysis after years of painstaking research. Neither was it a purely objective choice following the accumulation of incontrovertible data. The very fact that the vote was taken reveals the nature of the process involved, since the existence of an orthodoxy in itself, contradicts the essence of science." [22] When activists publicly claim that this vote was a scientific decision they hide three years of deceit and intimidation.

Pro-sodomy activists Kay Lahusen and Barbara Gittings know what really happened to the APA. In the book *Making History* they are quite open about the reality.

Kay: "This was always more of a political decision than a medical decision."

Barbara: "It never was a medical decision—and that's why I think the action came so fast. After all, it was only three years from the time that feminists and gays first zapped the APA at a behavior therapy session to the time that the Board of Trustees voted in 1973 to approve removing homosexuality from the list of mental disorders. It was a political move." [23] ...

Adopting terrorism as a means, pro-sodomy activists set their vicious sights on Dr. David Reuben ...

Denounced him as 'a criminal' for his views on male homosexuality. One policeman and a protester are injured in the melee." [25] ...

Apparently, the American Psychological Association also got the message of intimidation when they caved in to the demands of pro-sodomy activists in 1975.

"Under pressure from gay scientific groups, *Science* magazine banned anti-gay bias in its staff hiring and advertisement." [27] ...

One lesson from these facts is unmistakable: every time a scientific group repeats a pro-sodomy talking point, you may, with justifiable skepticism, suspect that these groups are acting out of intimidation. Another unmistakable lesson is that pro-sodomy activists are so desperate to cover their deeply dysfunctional condition that they will stop at nothing to hide the facts about their condition from the public. Award-winning writer and pro-sodomy activist Randy Shilts describes the denial that exists among many men who engage in sodomy, about the reality of their irresponsible and unhealthy lifestyles causing AIDS to be epidemic, when he writes, "... the desperation of denial: how when something is so horrible you don't want to believe it, you want to out it out of your mind and insist it isn't true, and how you hate the person who says it is." [29] Desperate denial this seems to be what drives the pro-sodomy movement's deceit, psychological manipulation, and intimidation of scientific groups and other opposing members of society.

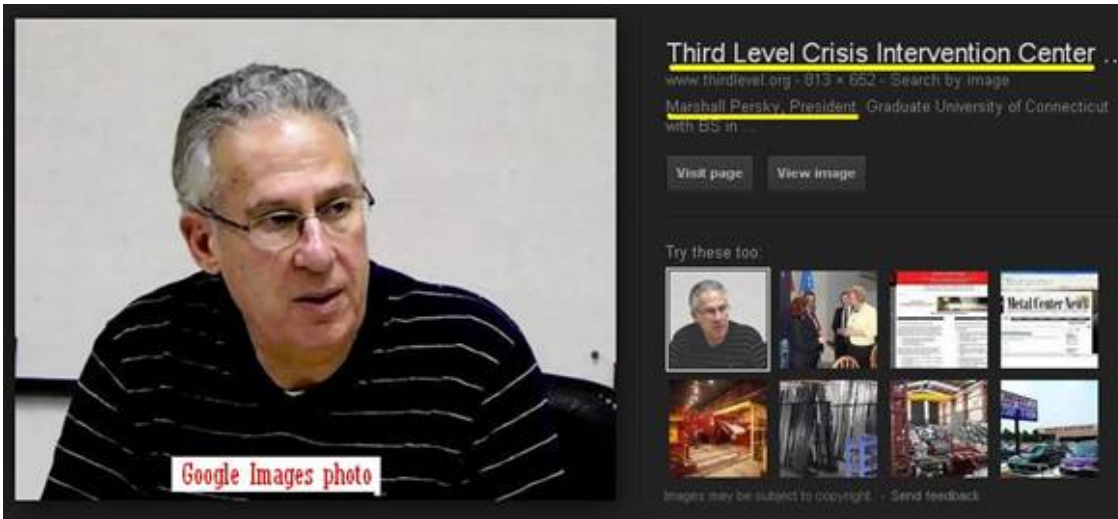

Bullying isn't, of course, just physical violence. Lady Gaga's mother, Cynthia Germanotta, who will serve as president of the Born This Way Foundation, says that one of the most hurtful episodes in her daughter's childhood came when schoolmates organized a party and deliberately excluded Lady Gaga.

Lady Gaga was reluctant to talk too much about her own experiences as a teenager for fear that her foundation would seem to be solely about bullying. THE FIRST AMENDMENT SUPREMACY CLAUSE

In no circumstance shall sexual orientation regulations supersede the First Amendment rights of individuals, churches and religious organizations to freedom of speech and the free exercise of religion.

For the purpose of this statute religious organizations are those whose policies or culture are substantially influenced by religious values, including but not limited to Christian bookstores, adoption agencies, hospitals, businesses, social organizations and student clubs on college campuses.

Statement of legislative intent: The First Amendment Supremacy Clause is designed to ensure that the first principles of the Bill of Rights to the United States Constitution, namely religious liberty and freedom of expression, are preserved and honored as essential values deeply rooted in our history and laws, as against the claims and reach of the newly invented category of law known as Sexual Orientation Regulations. It is the purpose of this legislation to clearly recognize and affirm that laws and policies based on sexual orientation, gender identity or like terms have no power to infringe upon or otherwise restrict the inalienable rights of Americans which are enshrined in the First Amendment, and which many generations of our citizens have shed their precious blood to protect.

FACTS

- The First Amendment Supremacy Clause (FASC) may be used as a stand-alone statute or as an amendment to existing Sexual Orientation Regulations (SORs) by government, corporations, non-governmental organizations or other entities.
- FASC does not prohibit laws or policies designed to protect homosexuals and other persons who define themselves by the practice of non-traditional sexual conduct from discrimination.
- FASC is only triggered when a claim is asserted that SORs should trump the First Amendment. In other words whenever there is a contest *in which one class of rights must win at the expense of the other*, the First Amendment must be held supreme.
- FASC is a complete barrier to the use of SORs as a sword to attack religious freedom and freedom of speech, which has happened all too frequently in recent years, but FASC preserves the use of SORs as a shield against irrational discrimination.
- Importantly, FASC recognizes that individuals and religious organization have the same status as churches in the assertion of First Amendment rights.

One of the primary benefits of advocating or campaigning for FASC is the clarity it brings to the debate over so-called "gay rights." The discussion of FASC identifies what is actually in conflict and at stake in this debate. It thus helps voters, policy makers and judges better weigh competing claims of rights and recognize the far-reaching consequences of their decisions.
