

**PC-#04 Bill Wiesner Public Comment #04 – to the Leelanau County Board of Commissioners: Tuesday April 19, 2022 ... We Demand Honest Elections in Our Leelanau County! ... by Replacing Dominion Voting Machines with Paper Ballots that are local, secure, and easily auditable.**

**Mesa County report finds 'illegal manipulation of tabulated vote data' in 2020 and 2021 elections**

A new report out of Mesa County, Colorado details illegal electronic "manipulation" of voting data in both the 2020 presidential election and the 2021 off-year election.

The [report documents](#) the findings of an examination of tabulated vote databases based on forensic analysis of the drive image of Mesa County's Dominion Voting Systems (DVS) Election Management System server (EMS).



According to the report, "the findings provide evidence of unauthorized and illegal manipulation of tabulated vote data during the 2020 General Election and 2021 Grand Junction Municipal Election.

Because of this evidence, which led to the vote totals for those elections

being impossible to verify, the results and integrity of Mesa County's 2020 General Election and the 2021 Grand Junction Municipal Election are in question."

Trump spokeswoman Liz Harrington noted that "25,913 ballots cannot be validated," for the 2020 election and "unauthorized election databases were created contrary to law."

Harrington added that the report states that 10 batches of ballots were recorded as being scanned in 47 seconds, "which is physically impossible."

The "same manipulation was discovered in the 2021 Grand Junction Municipal Election, affecting 8,540 ballots that cannot be validated," Harrington noted. Among the report's findings:

- There was an unauthorized creation of new election databases during early voting in the 2020 General Election on October 21, 2020, followed by the digital reloading of 20,346 ballot records into the new election databases, making the original voter intent recorded from the ballots unknown. In addition, 5,567 ballots in 58 batches did not have their digital records copied to the new database, although the votes from the ballots in those batches were recorded in the Main election database.

- The same unauthorized creation of new election databases occurred during the 2021 Grand Junction Municipal Election on March 30, 2021, followed by the digital reloading of 2,974 ballot records, making the original voter intent recorded on those ballots unknown. In addition, 4,458 ballots in 46 batches did not have their digital records copied to the new database, although the votes from the ballots in those batches were recorded in the Main election database. ...

- ... The true total vote count in Mesa County, Colorado cannot be accurately calculated for the 2020 General Election or the 2021 Grand Junction Municipal Election from records in the databases of the county's voting system.


- There is no function or feature on the EMS server that could be executed inadvertently or deliberately by a local election official that would cause this combination of events to occur, especially within the time frame that these events occurred. Given the complex sequence of data manipulations and deletions necessary to produce the digital evidence described in this report, this combination of events could not have been the result of either deliberate or inadvertent actions by those officials.

- Dominion's installation of the Trusted Build update on the EMS in May of 2021, as ordered by the Colorado Secretary of State, destroyed all data on the EMS hard drive, including the batch and ballot records that evidenced the creation of new databases and reprocessing of ballot records described in Findings 1 and 2 above. This destruction of all data by the trusted build is described in the "Mesa County, Colorado Voting Systems Forensic Examination and Analysis Report".

- The fact that such ballot record manipulation has been shown demonstrates a critical security failure with the DVS EMS wherever it is used. The manipulation would not be identifiable to an election official using the voting systems, nor to an observer or judge overseeing the election conduct, much less to citizens with no access to the voting systems; without both cyber and database management system expertise, and unfettered access to database records and computer log files (many of which were destroyed by the actions of the Secretary of State) from the EMS server, the manipulation would be undetectable.



Another FaceBook Post by **Eric Coomer** (Dominion Voting Machines head of "Strategy and Security") – first said that "... My faceBook account is not active" and "These individuals are impersonating me," but later he had to admit that the 80 slides from Joe Oltmann's "July 8, 2021 "Huge Coomer Update" show were copied from Eric Coomer's FaceBook page (see 1:05:46): <https://conservative-daily.com/cd-livestream/huge-update-coomer-dominion-and-activist-judges> When asked, "why don't you just change the votes?", note that Eric did not respond that the Dominion Voting Machines "COULD not change the votes; rather he responded: "Because that would be illegal." Last week at the 04/12/22 Board Meeting both **John Hunter** and **Commissioner Gwen Allraier** spoke up with much praise as to



how well the 2020 election was run by **County Clerk Michelle Crocker** and all the other

staff that worked on the election, stressing that there was "no shenanigans."

That goes along with what I stated in my first 2 flyers, saying that: "These changes by the machines were all hidden from the election workers, including the Clerks.)" And that is what is repeated twice in the 1<sup>st</sup> page of this flyer.

So now we all look at the election in Leelanau County the same way: the election workers (as far as we know) followed all the protocols they were asked to in order to best try to provide a fair election. But from the evidence from Mesa County Colorado, we see that the Clerks their had no idea that: **According to Tina Peters:**

**Report #1:** The Dominion Voting Machines' "Trusted Build" (Orwellian 1984) illegally deleted 29000 voting records that could have been used to prove how they get to the results of the election.

**Report #2:** Said that "there were 36 wireless devices in the system, which is illegal." She said that the 63 Colorado County Clerks who did not back up their files were in violation.

**Report #3:** Showed that they actually committed fraud and switched votes on a local city council election. (These changes by the machines were all hidden from the election workers, including the Clerks.)

But now let's consider the election another way: from the viewpoint of the 22,000 or so residents of Leelanau County. So if there is even a chance that this election truly was an attack on every man, woman, and child in Leelanau County, I would want to think that seeing this multitude of evidence, not only **County Clerk Michelle Crocker**, but also the other **11 Township Clerks and Northport and Empire Village Clerks** might be more interested in getting to the bottom of all this evidence than I am. So what will we see in the future from these key decision makers? Will it be a **"Queen Esther 'For Such a Time As This'"** moment? I hope so.



**The Correlation Coefficient (R):** (sample table from internet)

Strength of Correlation	Range of Absolute Correlation Coefficient (r)	Count of Subjects
Very strong	0.8–1.0	11
Strong	0.6–0.79	17
Moderate	0.4–0.59	27
Weak	0.2–0.39	33
Very weak	0–0.19	33

**Correlations involving human behavior rarely have R values greater than 0.8**

**Dr. Douglas Frank** calculated the "Correlation Coefficient (R)" for **9 MI counties** – including **Grand Traverse County** – which borders on **LEELANAU COUNTY**. One could easily assume from this data that the "R" value of **LEELANAU COUNTY** would be somewhere very close to the average "R" value of **0.997**, of which **Dr. Frank** exclaims: **"That ain't natural, buddy."** (i.e. It can only be done by a voting machine Algorithm (like a computer "recipe").



**Dr. Frank** calculated the number of ballots cast (above) in Grand Traverse County accurate to .996 "R" value. He can do this for nearly every county in Michigan (and across the USA.)
