Well, I'm talking about it here. So what the data showed and yeah, and **not just in Antrim, but it showed it actually in other counties as well** that I looked at, but **it gives you an example in Antrim, where the data didn't make sense.** So seven kiss you take up to Yeah, that's the one you're gonna have to zoom in. There we go. Very good. **If you take the two top Republicans running in the race for Justice of the Supreme Court, they got 37% of the vote. That's about four lines down and then if you look at the top two Democrats, they got 47% of the vote.** The other three candidates, a mixture of independent folks and so on, got 16% of the vote. Here's the problem. If you go look at the presidential race in that same county for a vote and Biden got 37% of the vote, **so it's a heavily heavily Republican county. And yet, the spread the if you add the difference in the Justice race, the Democrats were up 10% whereas they were down 24% in the president race that's a spread of 34%.** This does not make sense. And I know they say the Justice race is nonpartisan, but people know who's who they know if they're Republican. They know if they're Democrat. Mary

Kelly had been already been elected a Supreme Court justice in the past. Elizabeth Welch who won it was a newcomer on the scene. And it just looked to me in the data that Mary Kelly's votes, some of them were taken away, actually a very significant number and pushed out to a Republican candidate, which was why Brian schwarzsee and also half have given to Elizabeth Welsh which enabled her to win. It lowered, Mary Kelly enough, so where she did not win, but live that wealth, wealth came up to where she did win. **So I'm just saying it's possible. I'm not saying that's what happened. I'm saying, Look, we all said if there's an issue, just go count the paper ballots. That's why we have them, Democrats, Republicans everybody said that, if there was a real issue, go count the paper ballots. So why did there even be a lot of people doing all this in Antrim, they did a recount. They actually get a manual recount after they fixed the vote two or three times. To get to the accurate they went and did a manual recount. But the Secretary of State refused to allow them to count anything but the presidential race. They were not allowed. Good question. Good question. They didn't count the Justice race. They only counted and that she insisted on that they would not be allowed to count in other any other race.** They did exactly the same thing in New Mexico. There was Luna County, there was some races that were contested. They get new programming to only count the single race. That's silliness. It didn't cost anything extra to run the same programming recount every race and just double check everything would have been 15 minutes extra work to just you know, actually no extra work on the programming they actually had to do a lot more extra work to put new programming in. Likewise, **I was actually the very first person to interview Matt Turner when they got the the forensic audit up there and Antrim County as the first person and that told me for a while I was the only person that reached out to him for an interview.** So but I was I was I was actually, Mr. Lenberg. I was listening to you talk about Antrim County and I have been making a case for a long time I wrote an article up on the Gateway Pundit. It's up on my sub stack. I've been making a case for such a long time that given Jay Alex Halderman theory and Antrim County about the ballot design. **We we either have one or two of two problems either Antrim county is**

right. And DeKalb County is dead wrong. Or DeKalb County is right and Antrim county is wrong. Because in DeKalb County, they had the same exact thing. And you had mentioned that there's actually a failsafe in the election in the ballot configuration that if you remove a candidate, it won't go down ballot but in Antrim, they didn't have that you. I think I believe you. You said that this was because you could tell this because there was an excess number of votes that weren't originally counted in that race.

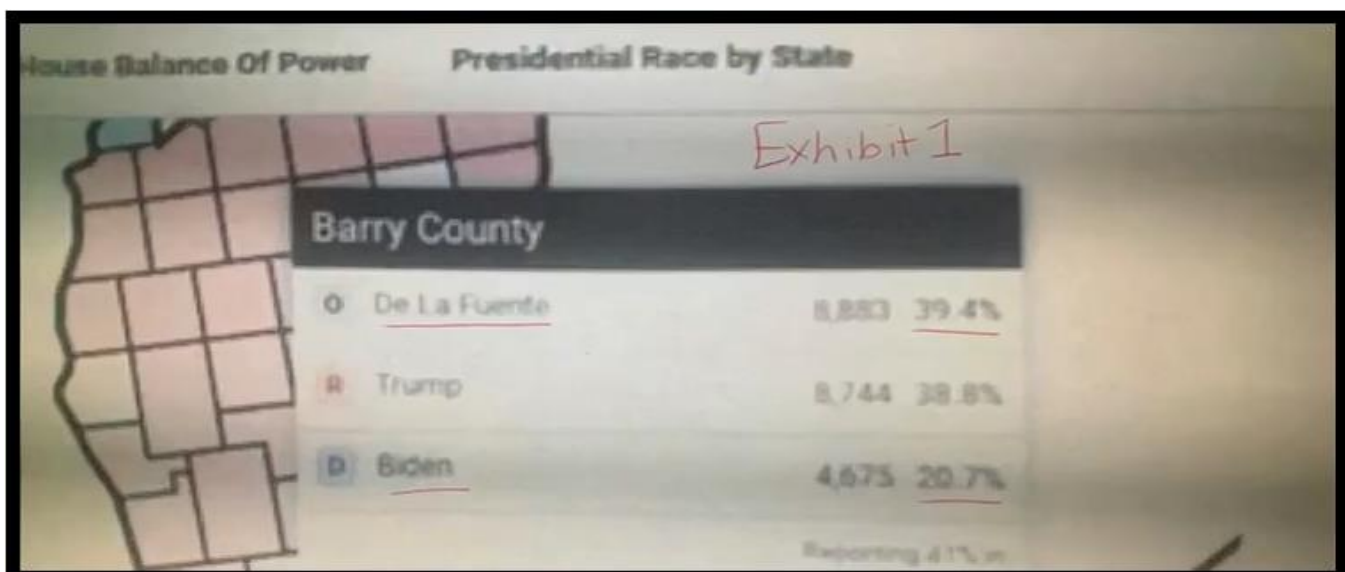

Okay, so this smoking gun has to do with the fact that what we identified up there was this shift so Halderman came in and said I can explain it. They did this last minute change. **The first thing that's wrong with that theory is that their software they advertise that you can make last minute changes, even after voting has started and it will not affect any other jurisdictions.** So they advertise that feature, but they didn't use it. Why? That's a real good question. They didn't use it. Instead, they re indexed the entire race all the races on the entire ballot in New Hampshire, which shifted all of the indices by one. Okay. So then if that's the case, great. What happens if you shift them all by one is the third party candidate gave their votes to Trump Trump gave his votes to Biden and Biden gave his votes to the straight party ticket, which was right above. **And we actually have a screenshot from Barry County, Michigan, showing rocky de la Fuente who was the third party candidate, getting like 8000 votes. In the middle of the night or 10 o'clock at night. He's actually beating Trump and Biden. Okay, and then magically, it goes away.** But the way he got those votes was the shift. It shifted past the boundary. They shifted to Rocky, they stopped the counting and then they had to go fix it in Barry County. We have a screenshot Okay, of that occurring. In barre County. It's in one of the expert reports. That's the Barry County report if you go find that one.



But the question is in Antrim, it didn't do that. So if it didn't do that, what did it do? It should have shifted them to Rocky. And by the way, it shifts absolutely every race. Every candidate every race, every choice on the ballot is wrong. Everyone is wrong, not just one race, all of them are wrong. So when it when you re-index the whole thing everything shifts. So that occurred, they were all shifted. And so what happened in Antrim, well Halderman said, Oh, it shifted and so we can explain it and and the votes went away. The problem I have with that is okay, did it check or not? Check for the boundary? That's what you're getting at in the call. Did it check or did it not check? There's the Barry county one. Yeah. That actually showed daylon Fuente ahead, and in the end he got like 35 votes and Barry County, let's say show them at night have an 8800 and some votes. Well, that's the interim shuffle. That's what occurred. All right. Now, in Antrim, it didn't show that what happened instead, is there was some checks being done and we actually traced some of the code just in this one specific area. And we see that in the electronic file, the caspo record that comes over to the AMS we traced it and we can see that it's got votes in there. Okay, not it everything in there is an actual choice, an actual vote. You have to process those votes. They're in the database. So it's going through it's processing the vote. It first says, you know, is this a vote that is in my, within this realm, you know, and it does a high level check first it says yes, I find this vote. Then it says okay, is this vote is this candidate in this race? It actually checks for that is this candidate in this race? And if the answer is yes, it processes it. If the answer is no. There should be an error handling routine that blows up because definitely automatically, because by definition, you couldn't have had that vote that candidate in that race. It's an actual vote from the tabulator, saying this candidate was voted for in this race by the tabulator. So it must be in that race. And if it's not, you've got data corruption, and you stop right there. You kicked that whole thing out that he cannot process that thing. Oh, that's a fatal error stop. But that's not what he did. It just ignored it and threw the votes away. Just throw them away. **So on election night, Antrim there were about 3000 votes that were thrown away. For Trump just thrown away. They were gone**

Now I showed the absurdity of this in one of my other expert reports, where I took banks and what I did is I went into the **EMS** and and Joe, we've talked about this one before, but it went into the **election management system.** It's all database space, right? So no password. I go in. I take and I take all the index for all of the candidates, one SQL command. Okay, but this long SQL command actually, that's not quite true. I had to run three, six, I had ran three SQL commands, because I ran two for I had swapped Trump and Biden votes. Okay, so I ran one for each one, but in the entire database. I could go in and swap their candidate numbers. Then I processed, processed it and that's when I was swapping the votes. And I showed that on that video in May of 2021. Then what I did in the banks one is I took the index and I shifted it completely off the ballot so I took the very first numbering indexing, which was called banks, that was their first Township. Okay, so that's where the indexing started. And I took us like one to 576 or something, and I shifted the index by that amount. **Now what that did was it literally threw away every vote for every candidate for every race on the entire ballot.** I processed 200 and some ballots, and there wasn't a single vote. It came back, all blank. They all had votes on it. They all came back blank was over 4000 votes that were thrown away and **the system did not complain at all.** It took it it processed the card it threw them all away hundreds of ballots 1000s of votes, and it didn't register a single vote for any race and **it said everything's fine. Here's your result. These are all blank ballots.** Okay,

You know, you go to Philadelphia, and and there are there are literally precincts in there that will have 300 400 500 votes for a Democrat and three for the Republican and people go oh, yeah, that's how we vote in this precinct. And I'm going it sure looks to me a lot like the antrum shift. Okay, it looks to me a lot like the interim shift. So that's how you would use it is this feature, this subverted feature, I love it as a bad guy. It's over 8000 ballot styles. I have the data guys I have the forensic images. Okay, it's over 8000 ballots files in Maricopa County. In Antrim, I think I had 43 or 46 somewhere right in that ballpark. And in Maricopa Now, one one reason it'd be that being that many is they they did a different ballots that are in Spanish and English. So you can cut that in half because every English style they had a Spanish one. Okay, but most other jurisdictions didn't do that. They just have a ballot that has Spanish and English on it. Why would you want two different ballot styles? Remember what I just told you? Here's why you'd want it you can customize it. Oh, of course all those Spanish speaking minority folks vote blue and vote democratic or vote whatever way you want them to. They're broken out separately by ballot style, which means it's got a different definition file, which means you can adjust it separately. **So in Maricopa you have 1000 dials, you can turn 1000 Because that's how many balance styles there are. I love it as a bad guy. This is the kind of thing I would design in this is this is really cool. It's horrible vulnerability. The whole system is Swiss cheese like this guy's a whole system is**

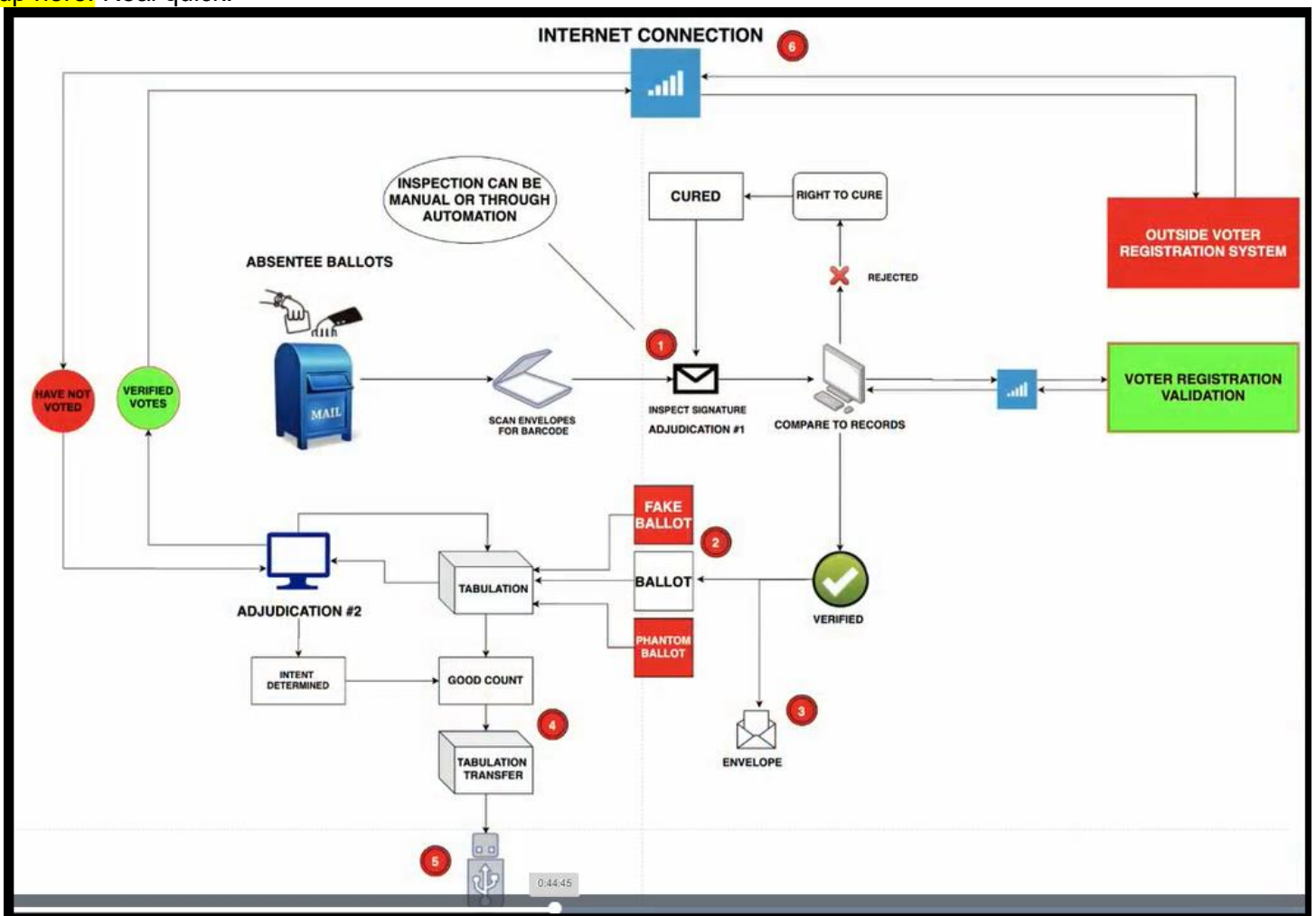

There's software on the EMS the election management system that you plug it in, it sees the card you say upload it, it uploads the card, and it processes the CVR the electronic results. It takes the images off stores admin takes the security logs off stores I'm supposed to do all that stuff. There are places I've told you guys where they turned it off. And where there's no reason why you'd even have a switch to turn it off. But they have the switch to turn it off and many people turned it off where they don't get the images they don't get the security logs, which is which is nonsense. So it's very simple. It's got the results in electronic format. They're encrypted. You plug it in to the computer and uploads it. Just like you take a file off of an SD card or USB stick, take it off of USB stick in some places actually use USB sticks as the transfer mechanism. Okay, so that's all it is. Now here's here's the problem I have. It's software 101 and Joe your engineering architect software guy, but software one on one if you have two different pieces of software that to work together must have the correct version of each. If you have version A over here and version C over here, that means they may not work together. Well then the very first thing you do in your software is check. You put a version number in and look at that card. You check it on EMS EMS knows what version it's looking for. And it says is it the correct version? And if it's the wrong version, you say timeout fatal error. Stop someone screwed up. We're not going to count this. Okay, we got to fix this that software went to one. **This is computer science, freshman class kind of stuff. Their software does not have that check** what it's doing what you described what it did in Antrim, that is, **you would never hire that software. company to do anything for you. Anything, any kind of software, because they're not following software 101 type of development.** A version check must be in there and the version is not. Alright, it's not there. It's not checking for it. It by the way, the later version of their, their machine in Maricopa in New Mexico. Does this have a version check? But in the log files, the security logs. It says they mismatched Oh, well we're gonna proceed anyway.

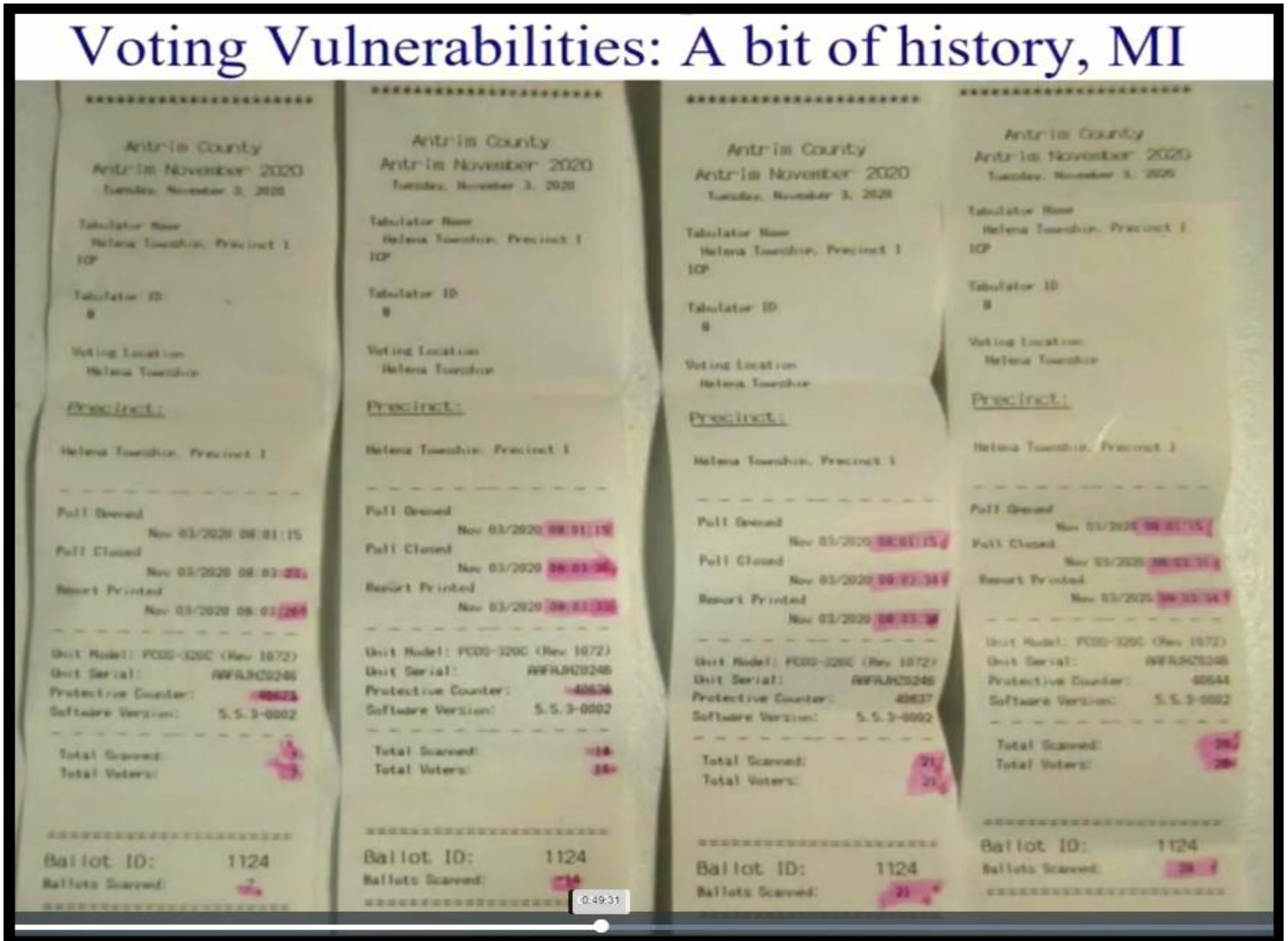

I believe this particular diagram was finalized the last week of December. We're like first week of January. Next to you so this right here. The reason why it's important is because I could not validate that China could come down in because you didn't need to write but if you go to this model, anybody who knows anything about system architecture or software knows that all you have to do is have something that executes something else. **And I talk about what they keep you away from that keep you away from paper. But as it goes through the verification process, you separate the envelopes from the ballot if you go down where it says three into and it's verified after it goes through the what I call the first adjudication, which is just the signature verification, right? It goes through a vote, and that can be compared to to your driver's license, data, all sorts of things that could be on site or could be off site. But after that's done and it goes over to where you see the part where it says to you can have fake ballots, which would be paper to paper ballots are fake, you would know because the paper would be different. That's one of Jovan, things that Jovan has been working on. Then you have the actual ballots, but then you have phantom ballots. And you can actually create ballots out of thin air like a ballot just appears inside the tabulation system. You can create a ballot in the system. Now, when you go through the adjudication process, when intent is determined, I can figure out somewhere between tabulation the adjudication of of those those ballots down to the tabulation, output or the USB drive, that somewhere along the line. We're behind by 2000 here 3000 There we need to add a few in okay, you know, we get our rep there to put a stick in and the rep doesn't even know they're sent something over their smartphone or you know over their computer and and and they go over there and he sickest **Oh yeah, we got to do this quick update on the system. Something's not right. And they can do run the thing that changes the vote. Right and and they may have just added 2000 3000 phantom votes and then if he'd be they can go back later and print receipts to match whatever they did on election night. And then when the canvas is actually done a week or two later, the tapes will match. Because you can create a tape long after the**

election that looks like it's election night. I don't know if you have that slide handy apologia. To pop up with the one that **actually has the picture of the four tapes on it from the expert report and Antrim,** that shows four different reasons. That you guys looked at in Travis County. I actually had given that to the all y'all because I found that mismatch. And so I saw this mismatch. **But in Williamson, the same thing happened and nobody would have caught that if it wasn't for a poll worker that kept the manual count on a post it note that to see what the ballots going through there were and what ended up happening is all these ballots going into a provisional folder. How do we know that at the end of the night, if they need to make up 100 ballots, boom, you go into this cache of ballots that are anonymously hid on the memory card that they never would have known about if it wasn't for this, you know, poll worker keeping tabs on a post it note and you have an unlimited cache of ballots to add and manipulate and adjudicate where you want them to be.** So it's not even that the fan or voters is not even a necessary thing. **This is a hugely flawed system. That right there should have been the end of Dominion.**

And the first thing is, is registration. You really want to get control over registration so you can bulk up the registration rolls. Okay. And you saw that done in 1993 with a Motor Voter Law, where they basically

took over the registration system, and more and more. We'll say a little bit more about that in a minute. So the registration system is one thing. Another thing that you want to do is **control the creation of ballots**. And they do this like crazy now there's no chain of custody on ballot images, the PDFs, you may not know this, but the PDFs actually sit on the EMS is unencrypted. **So anybody that has access to an EMS has all of the pristine valid images. You can take those yourself to a printer. You can have a printer at home. One of my reports talks about making your own ballots we made our own ballots in Antrim to test that out. You can make at home easily for a few 100 bucks you can make hundreds of ballots to win a local race. For a few 1000 bucks at home you could make 1000s of ballots. And if you go to high speed print shop, if you have access to one of those things, then you can make 10s of 1000s even hundreds of 1000s of ballots in no time flat with the high speed printers where you free voted these ballots and then you just have to stuffed them into the system some way okay?** You get them into the warehouse where they're doing the high speed tabulation. Somehow you get them into the system – 2000 Mules – whatever you need to do, you get them into the system but going back so you got to take over registration you got to take over the creation of the ballots in custody which is what we have now.

Then in 2010, little known fact they created this election verification work to handle election integrity. Well, guess what? It's a facade. In my opinion, **the whole election integrity thing that the government does is a facade**. When we look at the things we're talking about that you can tell, either they don't have experts looking at it, or they have experts that are purposely looking the other way. Because no expert is gonna say of course you can have a modem in there and connect everything electronically, remotely and you know, through an APN and the extra experts aren't gonna say that they're not going to allow that and yet it's there. And the certification authorities apparently have allowed it, even though I can't find it in the certification. So then the question is, why did they get certified so, the whole election integrity government EAC thing? I'm not saying they're bad people. I'm just saying they don't know what either they don't know what they're doing. Or they've got people in there should know what they're doing and they're looking the other way. Okay, I don't know what it is, but it's a mess. So they took that over in 2010. And go back to the slide there. In 2018

Excuse me, I skipped it in **2000 or 2002. The HAVA Act [Help America Vote Act]**, Hava is where they took over the tabulators. Okay, so Help America Vote Act billions of dollars to all the states to convert to electronic tabulators. And that's when they began taking over the mechanical voting. Part of the system. So that was 2002 then 2010. They took over election integrity.

And then in **2018**, there was actually another wave of HAVA funds **to get all of the additional people like Georgia was a last minute switch to Dominion machines and in Michigan only had them for a couple years**. So there was a bunch of funds that came in to get a bunch of them up to date with the latest paper optical tabulators.

And then in **2020** 2019, to see them bringing in **Risk Limiting Audits and Voting Works**. So here they're taking over the audits with computers, and telling you Oh, yeah, we've got this perfect way to do auditing. **It's great. Let us do your audits for you. We're gonna have the computers do it**. You don't really have to do it yourself anymore.

So basically, you've computerized everything. Let the computers do everything with **completely the voter registration, the tabulation, the auditing, the creation of the ballots**, and there's really no one in charge. There's no one that really goes under the hood, what's going on. **And I can tell you as a vulnerability guy, every one of those things is highly exploitable and this system is set up. It's got holes everywhere. It's Swiss cheese. So that's the text of what's happened and they've done it over decades.**

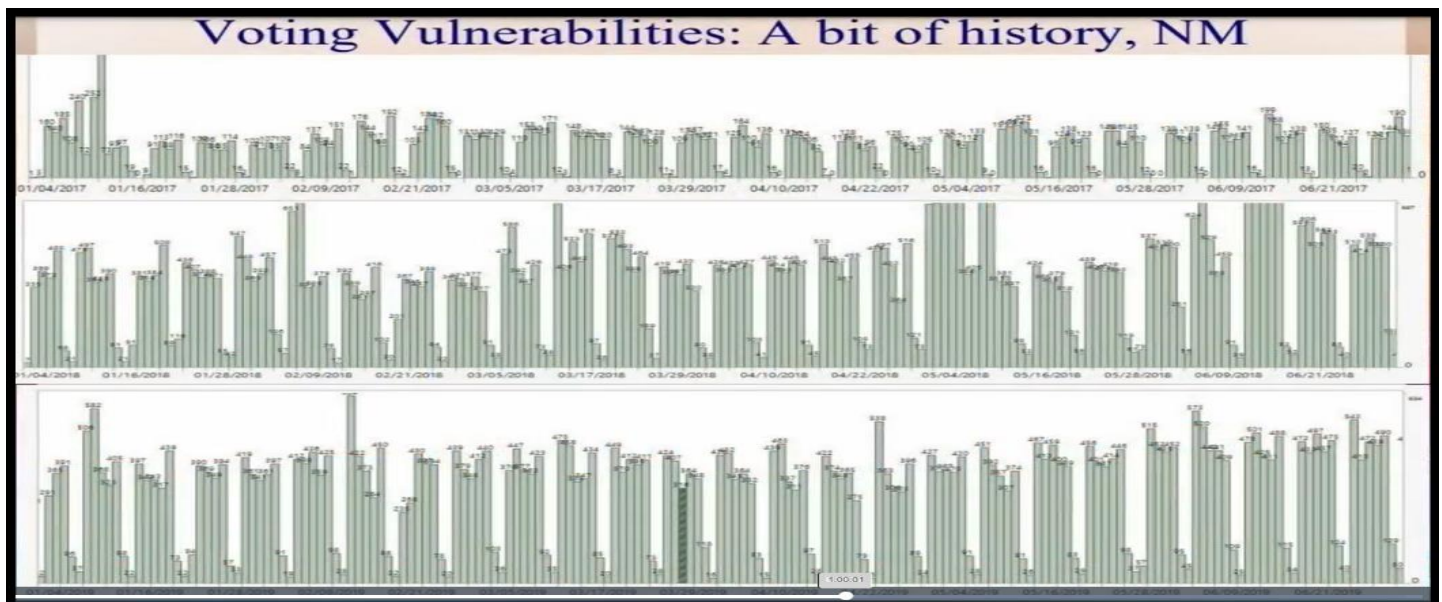

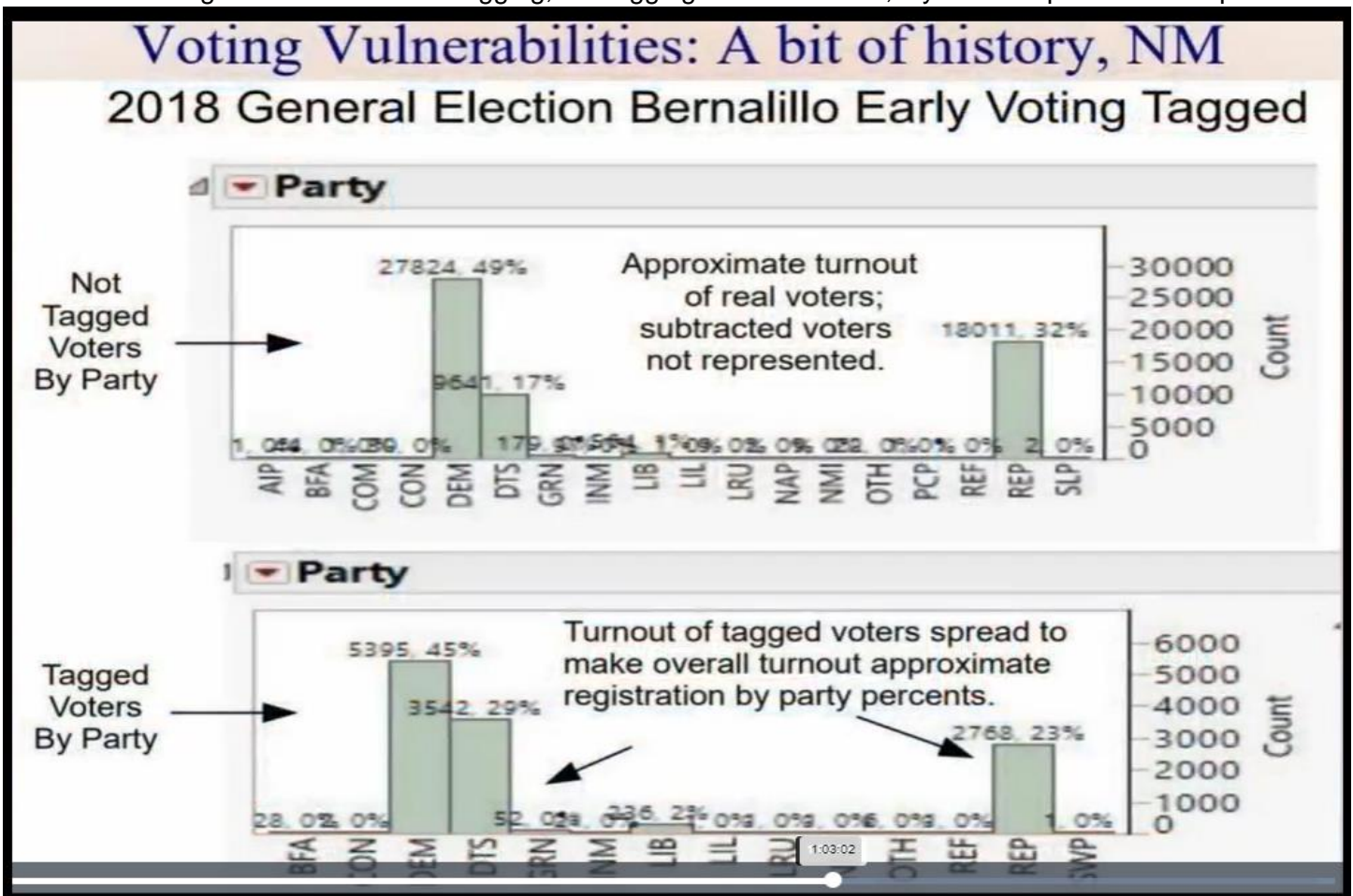

I had never thought about that. We got two Eric's here. And then Paul got a problem. So ERIC, d states in New Mexico is one of them. Hands over the complete vote motor data motor vehicle license database to ERIC hands over the registration rolls to ERIC with the idea that ERIC's gonna processes things and help us clean them up. They're gonna make sure that these people really exist in your state, that they're real people, not fake people. They're not. They're, you know, they're not phantoms and so on. So that's, that's the theory. And then of course, this is all funded by social and other folks like that, that have funded this kind of thing. So then what they do is they send back to your state a list saying, Hey, we found a bunch of people in your state who are not registered below if they look like real people in your state. We just thought we'd let you know that well, as a bad guy. I love that. Now, what they do on the surface is say thank you very much. We're gonna give those to all our county clerks and our county clerks, we're gonna mail stuff out to these people and tell them you know, you really ought to register to vote. But what if something else happens that we kind of see you in New Mexico and that is if you can put up the chart for me that has the three different paragraphs for registrations in New Mexico, the state of New Mexico. Yeah, that one there we go.



So what happened that top one, it is hard to read this guy, so I'll just tell you, it's running 100 and some [per day] per week, actually, each four days. So per week in 2017, it's running at **150 [per day]** or something like that. You'll notice starting in 2018, it jumps up to 400 and some little over **400 a day**. Okay. And then in the next year, it jumps up even higher and it's hitting more like **450 or so per day**. So these numbers are **absurd**. The state of New Mexico has turnover of about 60,000 people a year. We're not a big state, 2 million people have that 60,000 that turnover. At least half of them are kids not eligible to vote. So how in the world are we getting in in 2019 and 2020 in 2018 **170,000 registrations per year**, when we have maybe 30,000 people with the most who are moving into the state it doesn't make any sense. What happened in 2017, the beginning of 2018, you saw it was very local. And it goes up to like a factor of three is that's when our **DMV [Department of Motor Vehicles]** was directly connected to our voter registration database. So now that computers are totally in charge. **ERIC** does their weekend they did **ERIC**. **ERIC** DOS, they're saying they sent it back to us. Now a computer program can register people you don't even have to have a person show up. The computer can do it. And Aaron Clements did some analysis. I did some analysis where you look at it, and you say wait a second. These registrations are coming in on such a regular daily basis, repeating that there's something wrong here. It can't be that regular and if you go back in history, prior to all of this, it wasn't that regular, but it's very regular. It looks like a computer is adding people into the system. And these are the ideal people to put on the voter rolls because they've been vetted by **ERIC [Electronic Registration Information Center]** as being real people with real addresses. But they what you don't know is maybe they live in another state. Maybe they've actually been dead for a while, you know, maybe they moved to another county. Who knows maybe they were in this state 30 years ago, where they come from now why would you want to do that? Why do you want to bulk up the rolls? And there's a chart that you could pull up that shows the shifting of votes. It's called tagging, the tagging one that I have, if you could pull that one up.



Why would you want to do that? Okay, I'm not gonna go into great detail here. But I've mentioned elsewhere that we found in Cisco database that the database is actually tagged it's instrumented. And what it shows. In the top one, it shows the not tagged entries and the bottom one it shows the tagged entries and what you'll notice is there's a very significant shift where the Republican voters are tagged less; the Independents – DTS stands for Declined To Specify. So they didn't specify any party. And in Mexico, they're ridiculously high. They bolstered up to where there's only almost as many DPS as independents in the state as there are Republicans is ridiculous. But what you see is they're tagging these people at a much, much higher rate than they are the Republicans. It looks to me. I can't prove it right now. But it looks to me, like what they're doing is actually matching up with what we've seen on the ground and Otero what we've seen in Maricopa, which is people vote, if then what you have to do, if you're going to systematically shift votes in your machines, you have to have the voter history approximately match what you did. So what you do is have the computers go and take and not mark for certain people, in this case the Republicans and so they didn't vote, and instead Mark independents DTS is that didn't vote but you mark them as having voted. So you get rid of that slide. But that's the reason why you want to bulk up the rolls is you want to get a ton of people on the rolls who especially are in this in between. They're not any party. They're neither one of the major party, because now you can use them either way. The bad guys want a lot of people on the rolls, who are not likely to vote either because they're not real, or they're in some category like maybe they're an illegal immigrants that somehow got registered to vote and they're going to be scared to go to vote because they know they shouldn't vote. They want a lot of people on there that are not going to vote, because then they can mark them as having voted. And when I say they, I mean a computer algorithm can do that. This doesn't take people that is done behind the scenes by computer algorithms, not by people. Does that make sense? It does all that. So that's the registration.

The other thing I'll tell you about this that I don't know if I highlighted last time, but the polls so if you remember in 2016 and again in 2020, the pollsters were ready to pull their hair out now many pollsters are you know, they fix their polls. They honest pollsters, and we know that there's people out there that are rigging polls, but you know what, there are honest pollsters out there who are trying really hard to get it right. And they didn't get it right either. So I want to talk to those people. Here's my theory. If no one explained no pollster or anybody else how they get the polls wrong. Here's my theory. So you mark people as having voted in that in between category [DTS] who actually did not vote but then the pollsters use the previous turnout to do their poll. That's how they decide how many pollsters how they decide what the sampling is supposed to be. It's they do it based on previous turnout. Okay, do you follow that? So if they do that, and it's been artificially shifted, when you go do the poll, guess what? It's going to be artificially shifted by the amount that the voters were shifting, because you're polling the wrong people. A percentage of a high percentage of like 15% are the wrong people. And if you remember they were literally off in many hilarious by 15%. White morning or more. So I claiming that a possible explanation is that who voted is not properly recorded in the databases in many states. And that is why the polls are off. And if you could go back and find out who actually voted in those elections, and take that shift out. The polls could be corrected, and you probably get a much more accurate poll.

I mean, that election has been known for years when that election was going to be, and there's no reason you should wake up on election day and decide you want to vote that day. And if you do, you're so irresponsible, that you shouldn't be allowed to vote in my opinion, and that's not voter suppression. **That's what voting is. A right. 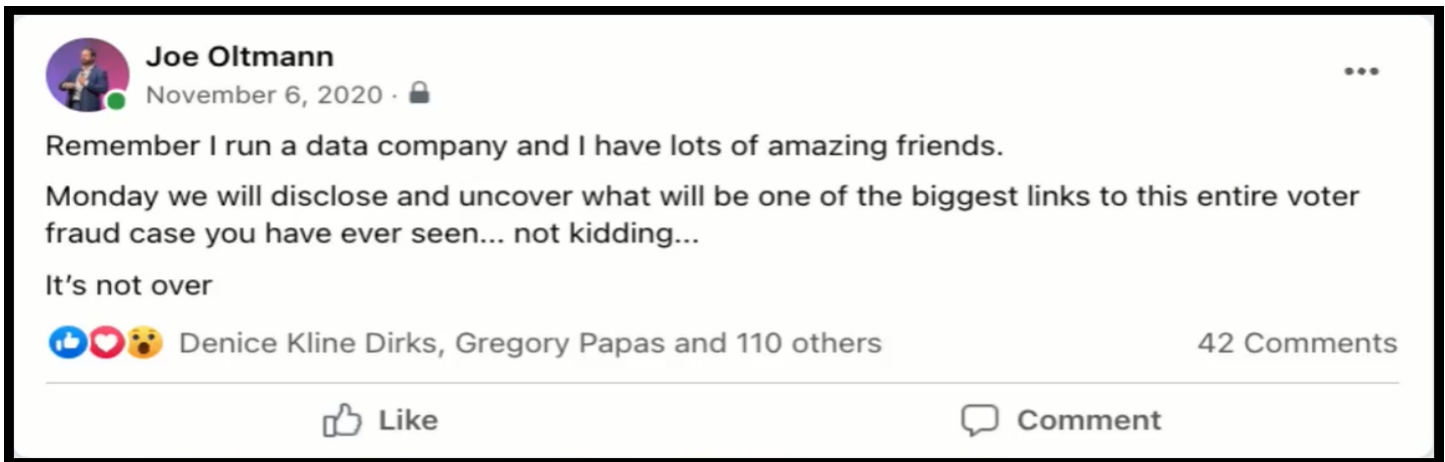



The ImageCast X can be configured to allow a voter to produce a paper record or to record votes electronically. While these vulnerabilities present risks that should be mitigated as soon as possible, CISA has no evidence that these vulnerabilities have been exploited in any elections.

Exploitation of these vulnerabilities would require physical access to individual ImageCast X devices, access to the Election Management System (EMS), or the ability to modify files before they are uploaded to ImageCast X devices. Jurisdictions can prevent and/or detect the exploitation of these vulnerabilities by diligently applying the mitigations recommended in this advisory, including technical, physical, and operational controls that limit unauthorized access or manipulation of voting systems. Many of these mitigations are already typically standard practice in jurisdictions where these devices are in use and can be enhanced to further guard against exploitation of these vulnerabilities.

2. TECHNICAL DETAILS

Exploitation of these vulnerabilities would require physical access to individual image casts x devices access to the election management system, or the ability to modify files before they are uploaded to image cast x devices. They basically say, up above, first paragraph at the end last sentence: While these vulnerabilities present risks that should be mitigated as soon as possible. So I says no evidence that these vulnerabilities have been exploited in any elections. **So once again, they have no evidence of but of course, they haven't looked for any evidence.** So they have no evidence so they can say that, but what what they're saying here, basically is look, these machines have some issues. And And down below that gives the technical details which when you look at it, it blows you away. We're not going to go through all of them. But once you go down to 2.5, we'll look at just that one, maybe 2.32 point 2.3 And two point you go up to two point three. **The reason is there's this whole class of hidden functionality. The ability to print tapes out falls under hidden functionality,** you know, the paper tapes. They tested this version, terminal or application a terminal emulator application, which **could be leveraged by an attacker to gain elevated privileges on a device and or installed malicious code. So there was something on there a terminal emulator that basically once you're on the machine, you can do whatever you want it to that machine,** go down to two point 2.5 If you would, that's the only other one I want to touch on here. And that is the tested version of in cast. eXe can be manipulated to cause arbitrary code execution by specially crafted election definition files. An attacker could leverage this

vulnerability to spread malicious code to image cast x devices from the EMS. Now, what I want you to notice here specially crafted election definition files. You remember my May 2021 video where I swapped the votes. Those were specially modified election definition files. And I've written election an expert witness report that you can do that centrally, **they lead you to believe here that you have to have physical access to the EMS or to the tabulator to do this, and I'm telling you you don't that election file can be modified way upstream. And basically they say in the free port. Oh they can run malicious code and do anything they want on that tabulator. And I'm telling you, this could be done way upstream. You don't even have to be in the state. You don't even have to be in the United States. You could be in some foreign country and you get into the server wherever they're running that election event designer. And you hacked that. And now you're in**

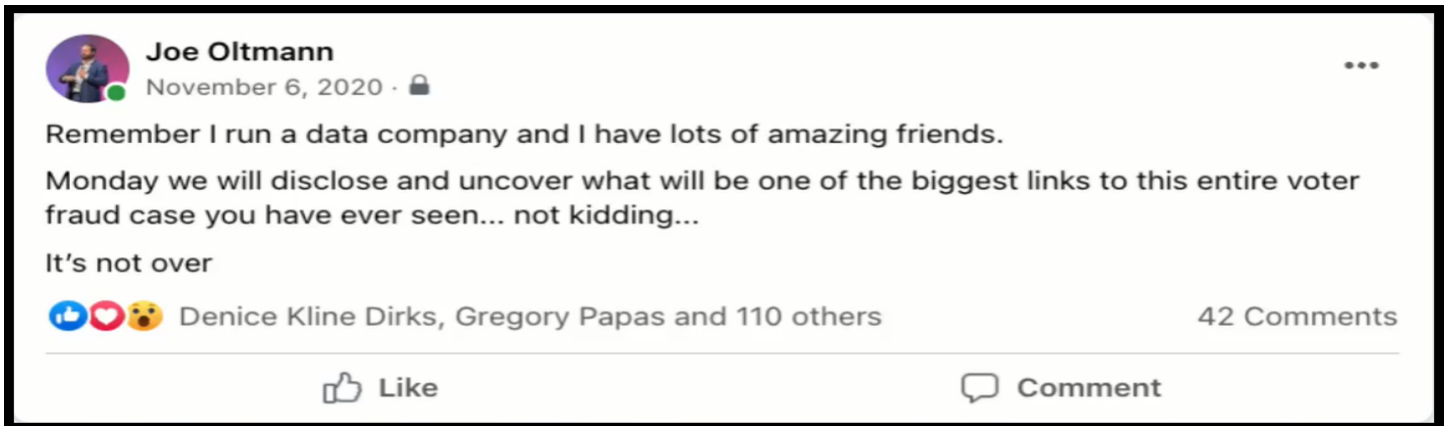
