Well, Cast Vote Records for those who don't know, it's something that we figured out last year, was available from most of the places that allows you to see vote by vote, ballot by ballot, how the election unfolded. So it lets you replay the election from start to finish. In a lot of cases, you know, down to levels of precincts and tabulators and all that good stuff. You can even run it backwards to forwards which believe it or not, is also a technique that we use to do that. And one thing to look at is to see if we think of these black box election machines that we have, you know, if you think of them as a Photoshop or the Cast Vote Records is what is the final version of what they Photoshop. In other words, it's what they're admitting to or it's what they want us to see. And because of that, we're able to see patterns in the voting that are not natural, not normal or definitely not done by a bunch of people, you know, coming in and casting votes.

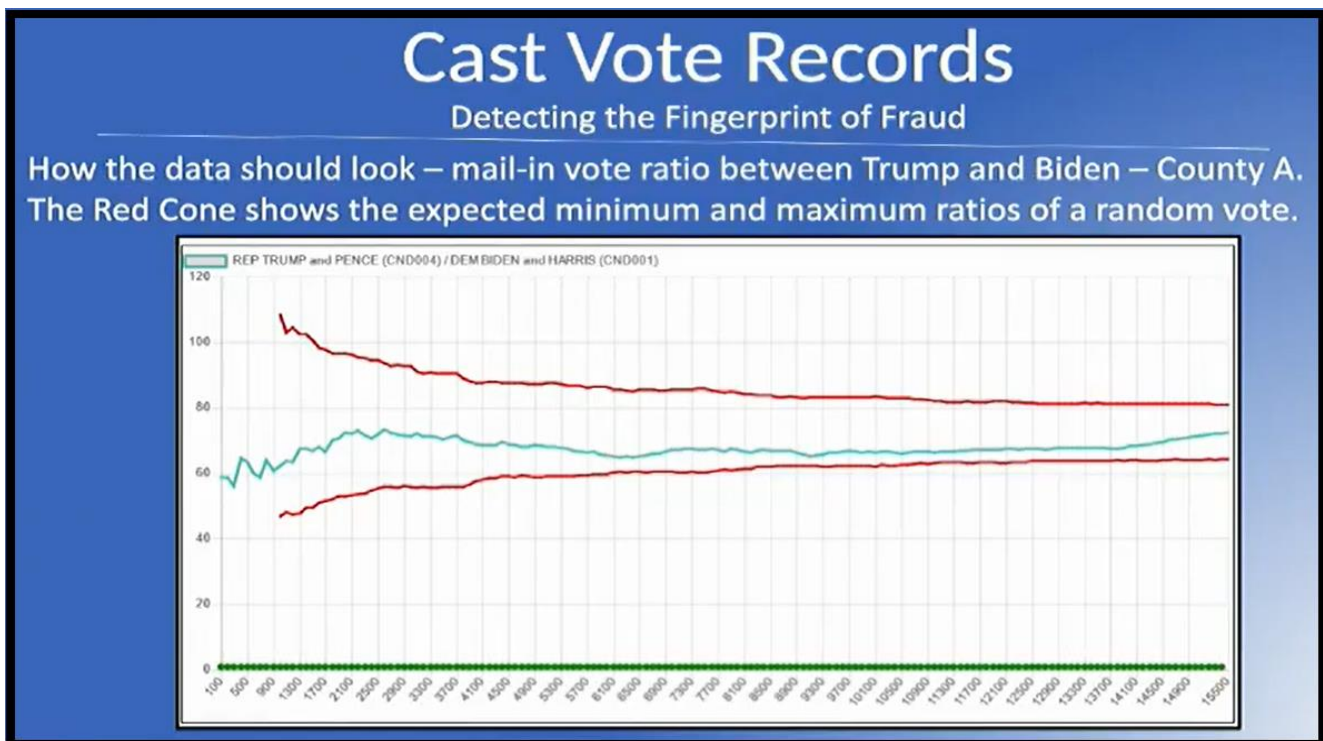

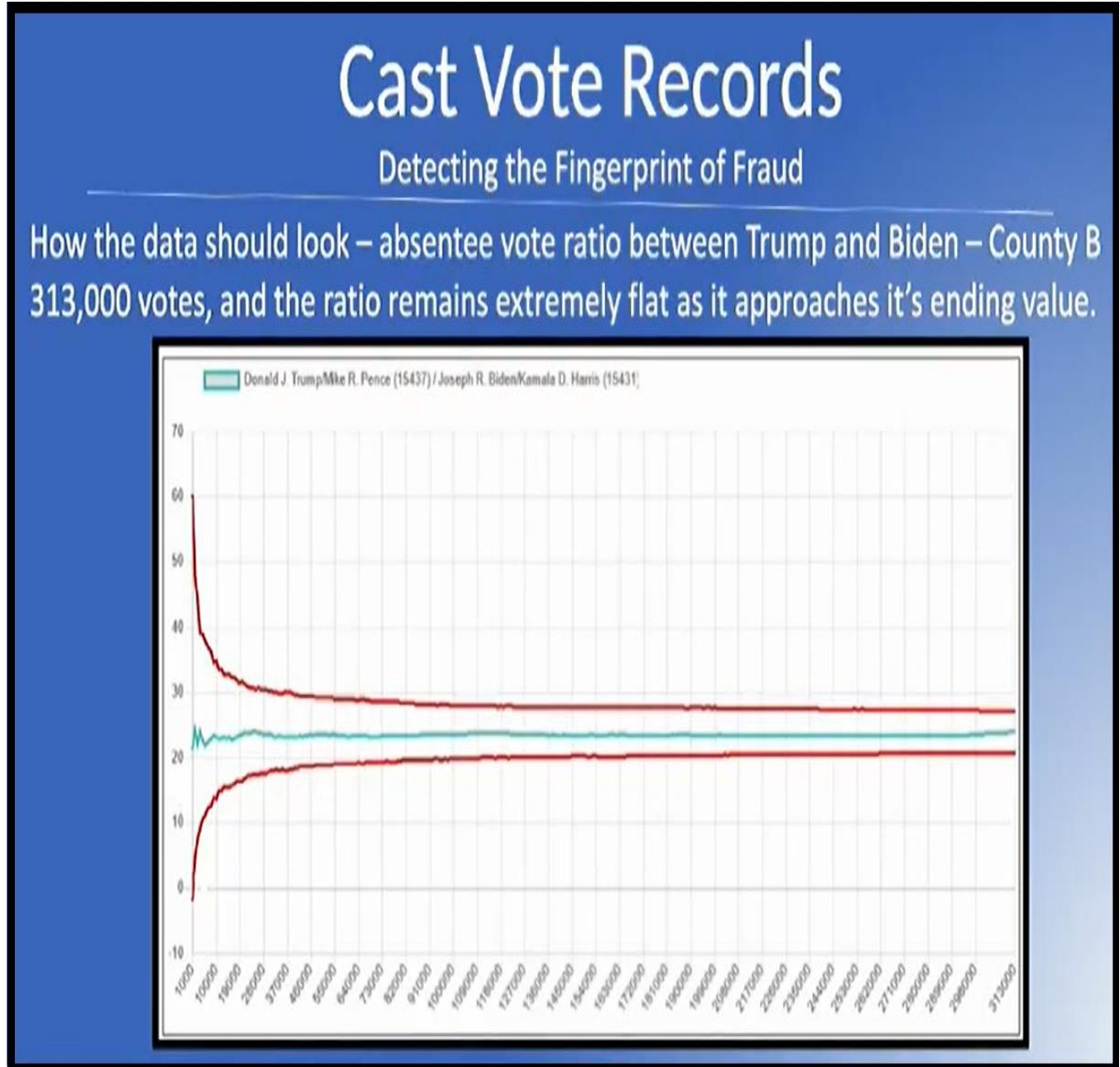
All right. **So you want to go ahead and show the slides. I've got the first one here.**



All right. So I'm gonna try to go through this and it's recently. So basically what I'm saying is that the blue line – what we do is we take the number of Trump votes and we divide it by the number of Biden votes at any point. That's just a handy way to do it. We also have a feeling that that's how the bad guys looked at things. Sometimes we do it Biden votes over Trump votes because you see different things, there's a whole lot to this. But the point is what you're looking at here is a county and this is their mail-in vote from the county. We have done months and months and months of work to prove to our own satisfaction, that the mail-in vote in a county should be fairly random, meaning it should – the red the red cone is

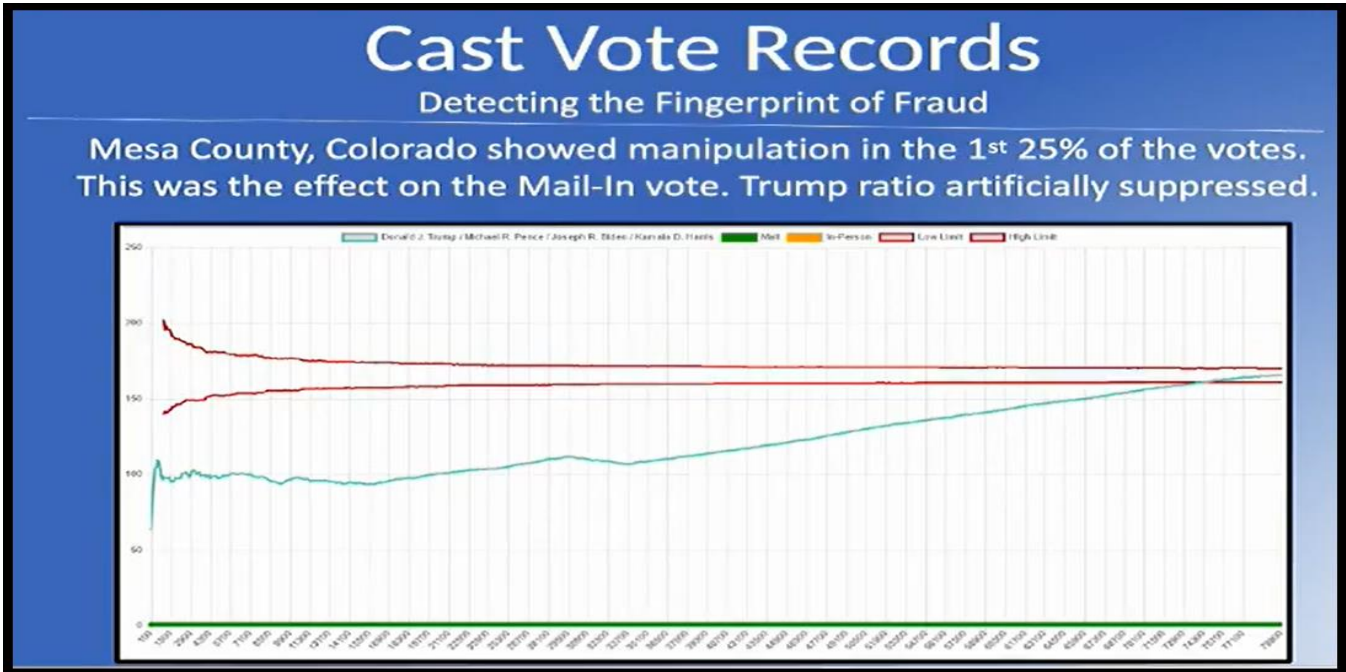
basically if it's a fairly random and we when we actually err on the side of caution, but **it should fit at any point during the vote.** So from the beginning, that's when the voting started, and the very right hand side is when the voting was finished counting. You'll see that ratio stayed very close and is inside of that red line. That is what we expect. We've also gotten some **Cast Vote Records** from previous years. And we see the same thing very often. So this is the normal, this is what we would expect. And when we say that there are some, you know, a small amount of counties that we've not seen this this obvious problem in, this is one of them. And there's an example and then obviously if you're going to say there's a problem, you have to point to something and say, Well, it's a problem because this is normal. This is normal.

Can you go to the next slide? You're gonna see another county, this one with a huge number of



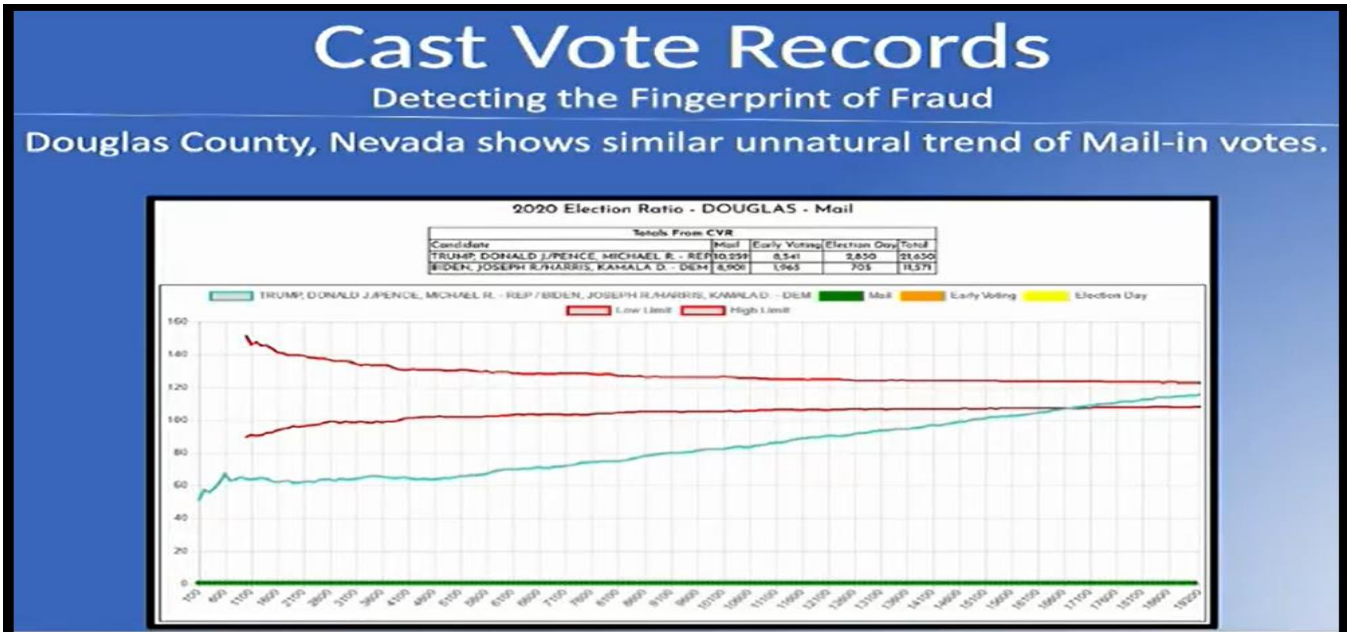
votes. That one has hits right down the bowling alley middle there under that pin. In fact, we call it about this one that this may actually be too, too flat. So But nevertheless, you expect to see it within that and that this is one of the ways that we determine you know, the extent and how much problems or maybe with the county.

Alright, go to the next slide, please.



So Mesa County, Colorado, which of course is near and dear to my heart because I was able to actually find evidence of manipulation in the manipulation happened in the first little more than a quarter of the votes and the blue line again is the is the trump the Biden ratio and you can see that it starts abnormally low and finally doesn't even get into that expected area where it shouldn't be until the very end. And the manipulation that happened early in that is what caused what you're seeing on the left hand side. It should be up in between the red or at least very very close to that that Red Funnel red cone. You see it's quite far below it and rises dramatically after the point where the we saw the manipulation happen. So that keep that in your mind.

I've gone to the next one.



This is another county and then this is Douglas County, Nevada. Look a little familiar. It's basically very similar to that and the same pattern starts at an abnormally low.

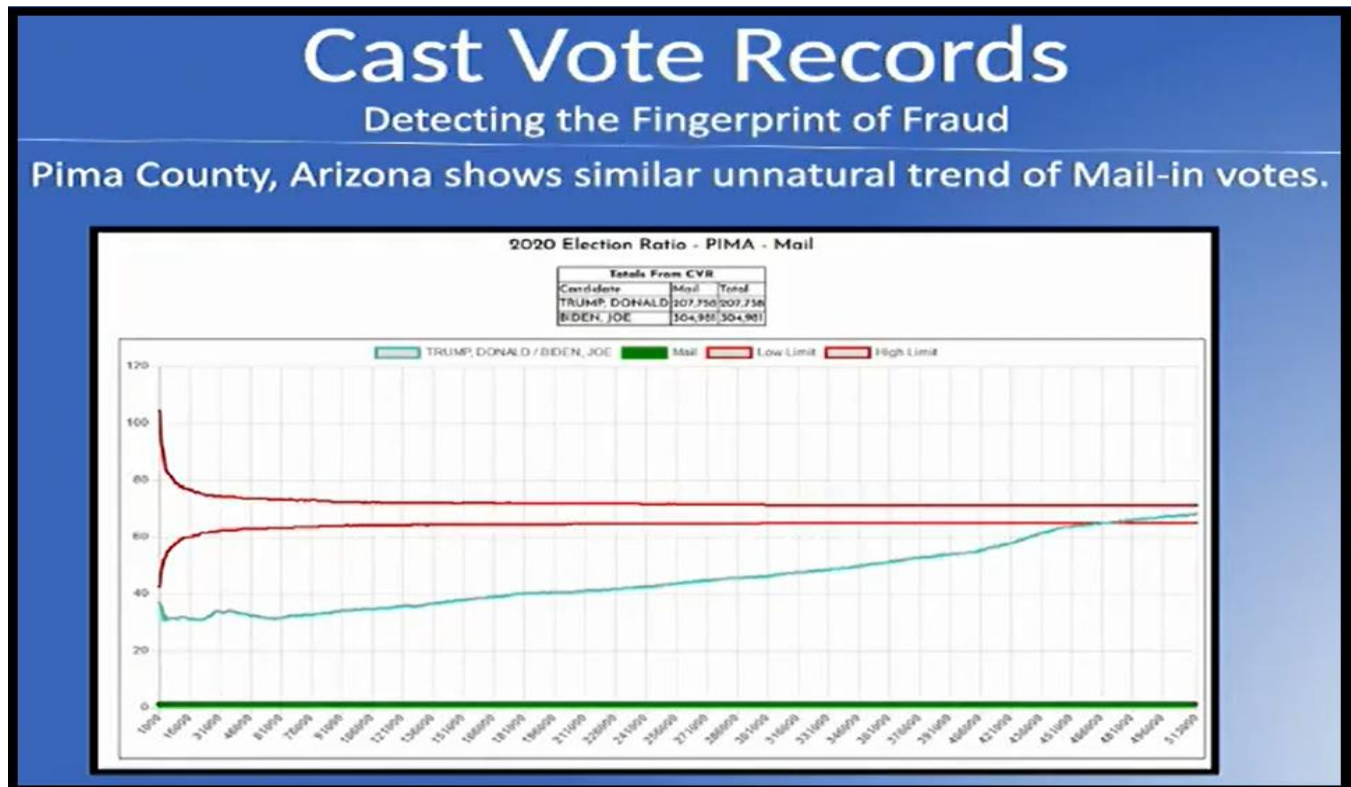

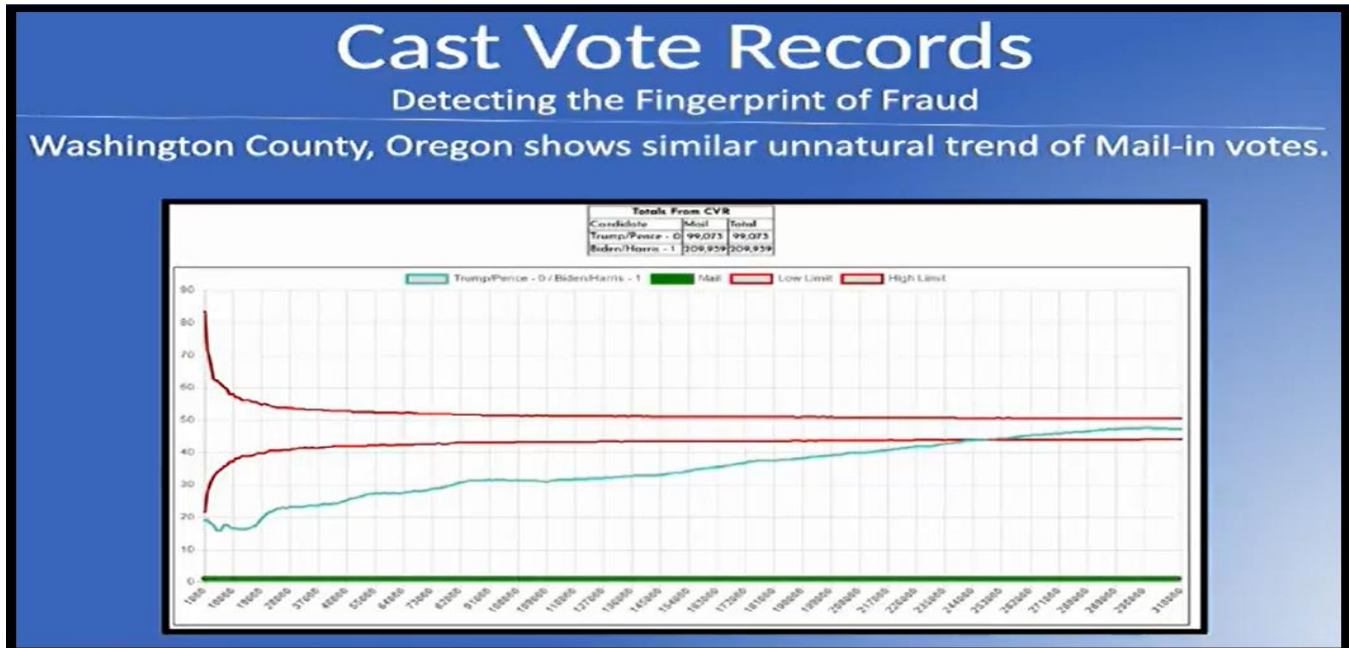
Well, that's what I'm seeing in I'm almost looking at this because I'm such a data and software guy. I'm almost looking like an art critic, look at a painting and if you look at one painting by Rembrandt and you're an art critic, and somebody puts another painting in front of you, and you're gonna be able to turn right away. Oh, that's Rembrandt. Well, I've seen the same hand at work in these in these two. So, you know, again, this, this is what it looked like in Mesa. And then the next one was looked like in Douglas.

And now, go to the next one kind of interesting.



This is Pima Arizona. You might notice something kind of familiar about that. Now, You know, these are different number of votes, but you still have the same basic pattern. Again, these are all mail-in votes. So you can't say oh, the ones that the end or the or the Election Day votes, because we always know the Election Day favors Trump. Yes, they do. So we're not using them and this and that this particular analysis. This is only the mail-in vote.

Now there's one more to show this is Washington County, Oregon.



A very similar pattern to that as well. Again, it starts low comes up. Generally we see that this is you know where it starts. It basically goes between one and a half and three times where it started. By the time it reaches the end.

If you go to the next thing you'll have the this is the this is the thing to remember.

I think what this shows that there is evidence of an algorithm that is being used to manipulate the outcome of an election regardless of the vendor. And that can be done through many ways, whether it's a remote access, whether it's a script in the software, you know, those are those are by which that can be done. There's one thing I'd like to add and get Jeff's opinion, but one thing that has struck me because we have used this analysis in two cases so far, and another metric that showed manipulation, was the fact that the line or the slope was predictable. In other words, as more batches were processed, that you could tell what the what the next batch was going to be in terms of the Kimba [?] to vote ratio. So if it started out at three to one, the next batch it might be 2.99, then 2.98 and 2.97. And it would rise up into the final set point at a very predictable level, which means that it is artificially controlled.

we talked about at the **Moment of Truth Summit** [<https://frankspeech.com/shows/moment-truth-summit-start-finish>].
