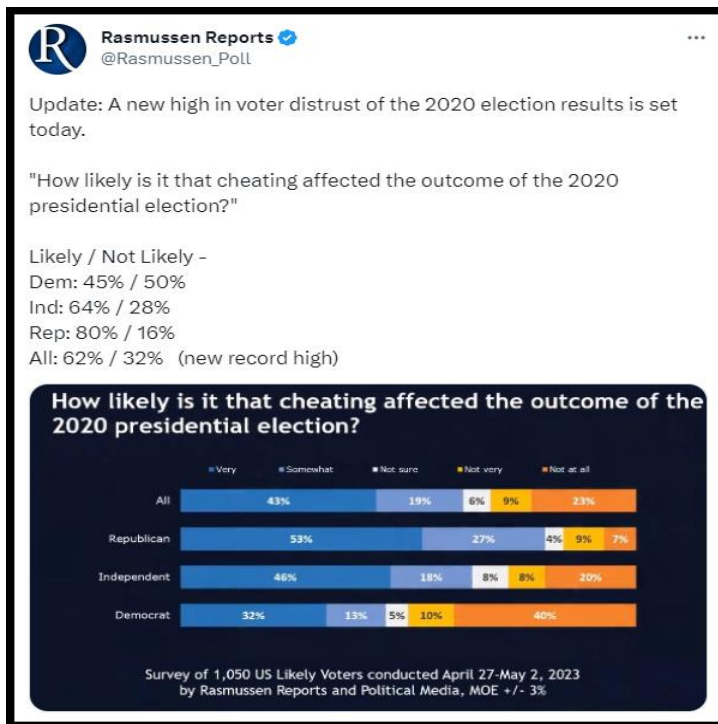

Below is the percentage plot of President Trump’s mail in votes in Mesa County, CO during the 2020 General Election.

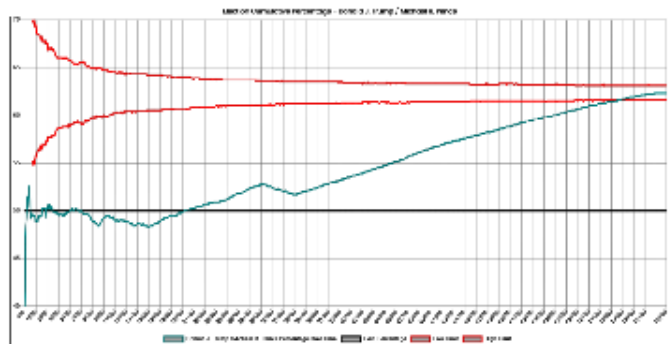
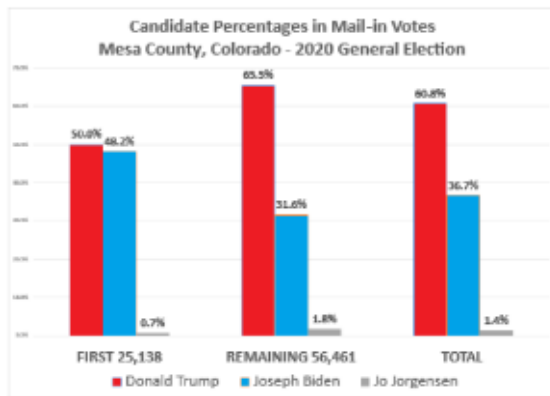


Chart Showing the Results of the Election Fraud:

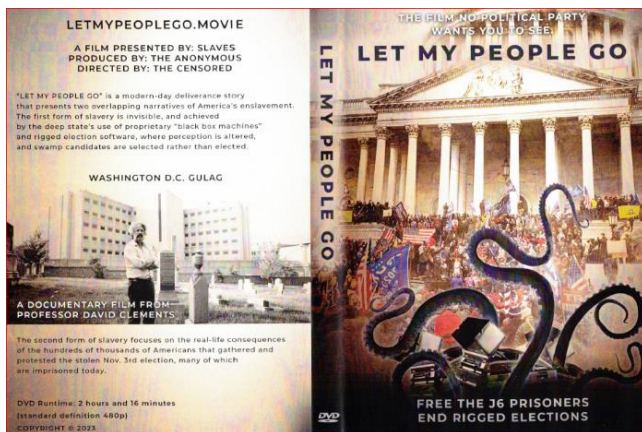

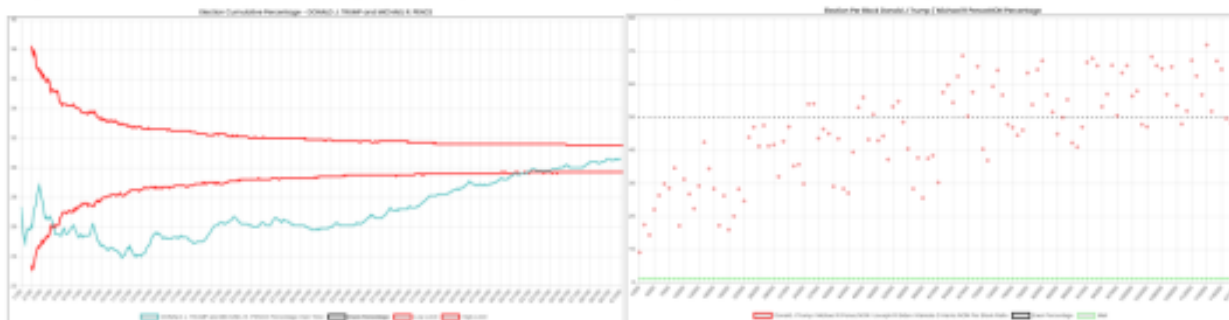
"Fingerprints of Fraud" 2020 Election Cast Vote Record Report, Volume 1 Summary of Findings by Jeffrey O'Donnell (Jeffrey.odonnell@protonmail.com)

The information presented here is a top-level summary of the "Fingerprints of Fraud, Volume 1" report. Much additional supporting information can be found in the complete report, available at <https://FingerprintsOfFraud.com>.

The findings are taken from the 2020 General Election Cast Vote Records (CVR) of 202 counties from nine states, Arizona, California, Colorado, Idaho, Nevada, New Jersey, Ohio, Oregon, West Virginia. A CVR is a record produced by the election computer which shows each ballot processed and the votes which were counted on it, in most cases, in the order of processing. (If the order of the CVR was changed or sorted, this analysis cannot be performed.) They can also include the precinct, tabulator, batch, ballot style, and voting method. No voter-specific information is included.

Because mail-in ballots can be expected to be received and processed by the county in a random order, **only mail-in ballots are used in the analysis**. Since they show a random receipt pattern (based on metrics such as precinct distribution of the ballots), the votes upon them should generally follow the Law of Large Numbers, which dictates that the more samples you have of a random population, the closer their cumulative average should be to the final average. (Think of a series of coin flips or dice rolls).

1. 168 of the 202 counties, or 80%, fall into a similar pattern where there is an initial high advantage for the Democrat candidate, and at some time before the midway point that average gradually turns toward the Republican candidate. Following is a sample that shows this pattern in Mesa County, Colorado.



The red lines on the left-hand chart, which shows the percent of mail-in votes for Donald Trump during the counting (shown in blue), indicate the range which would be expected from the Law of Large Numbers. Instead of expressing the expected pattern, there is a large initial series of votes favorable to Biden, followed by the general gradual increase to the final average. The right-hand chart shows the Trump percentage for each consecutive 100-ballot batch, and the gradual upward pattern is apparent. As I first noticed this phenomenon in this county, I refer to this as the "Mesa Pattern".

2. The 168 counties referenced above also share a "predictive" aspect. Namely, the percentage which Donald Trump had at the end of the counting is 1.1 to 1.3x the percentage he had at the midpoint (with most hovering closely around 1.2).
3. Nearly all the remaining counties which did not show the Mesa Pattern were either very small (under 4,000 total ballots) or showed signs that the CVR was sorted by precinct or other index.
4. Statistically speaking, the chances of 168 counties in 9 states spread across the country demonstrating this same unnatural pattern are too low to be calculated.
5. The 168 counties showing the Mesa Pattern spanned five different election vendors: Dominion Voting Systems, ES&S, Hart Intercivic, Clear Ballot, and Smartmatic.
6. Numerous counties in other states also demonstrate this pattern and will be detailed in future volumes of the report.

These findings demonstrate proof that the mail-in votes in the 2020 General elections in those states were altered via a software algorithm. Please see the entire report (URL above) to view the complete details of each county analyzed.

She told me that she would have to check with **Dominion's Michigan 'Election Source' vendor**, and that she would 'follow up', and that I should stop by the office the next time I am up at the Governmental Center (which I have yet to do).

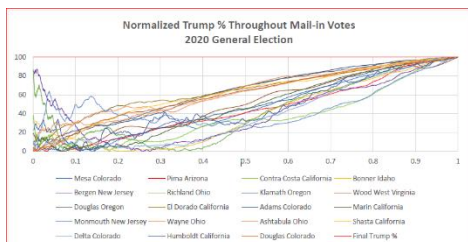

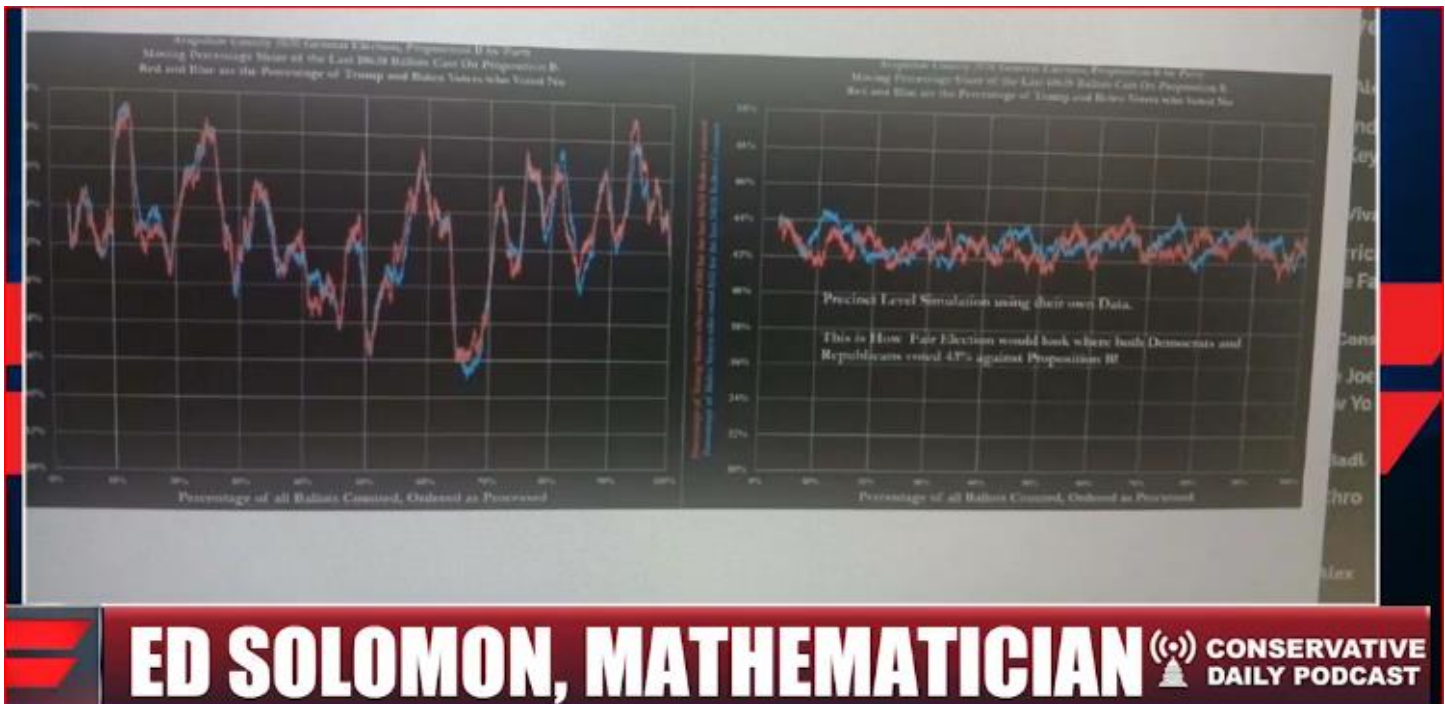

Gary Berntsen: Hello, my name is Gary Berntsen. I'm a veteran of the United States Air Force and a retired Senior Operations Officer and Chief-of-Station of the Central Intelligence Agency.



For over three decades, I served in the US National Security apparatus, in various capacities.

Shortly after the attacks of 11 September 2001, I entered Afghanistan and commanded CIA paramilitary forces, helping seize the cities of Talaqan and the capital of Afghanistan, Kabul.

I was the driving force and architect of the [Battle of Tora Bora](#). I held the position as Chief of Hezbollah Operation in CIA's Counterterrorism Center for several years and concluded my service in CIA as a Chief-of-Station in Latin America, combating narco-terrorists.

Approximately six years ago, a business associate and I began working together as whistleblowers for the Department of Justice, FBI, DEA and Homeland Security Investigations (HSI). Our target was the largest and most well-funded transnational criminal organization on the planet called the [Cartel de los Soles](#), "Cartel of the Suns".

The *Cartel de los Soles* is the Venezuelan government and is led by Venezuelan President Nicolás Maduro, [Diosdado Cabello](#), [Minister of Defense Vladimir López Padrino](#), [President of the National Assembly Jorge Rodríguez](#), and former [Directorate General of Military Counterintelligence Hugo Carbajal](#), who was detained in Spain several years ago and extradited to New York. He is currently awaiting trial for narco-trafficking.

Venezuelan President Maduro has a US indictment and bounty of US \$15 million for his capture. Diosdado Cabello has US indictment and a \$10 million bounty on his head. At least six other Venezuelan cabinet members and senior officials are indicted.

In the last 20 years, the *Cartel de los Soles* has stolen \$1 trillion US dollars from Venezuela's national oil company, PDVSA, and embezzled \$500 billion US dollars from its national treasury. It not only has – but continues to produce and smuggle – 25 to 40 metric tons of cocaine every month, out of its country into the world.

The *Cartel de los Soles* is a \$2 trillion transnational criminal organization and the most well-resourced criminal syndicate in history. Through bribery and investments of its funds, it controls a dozen countries and world leaders. It has massive investments in the US and European financial markets and institutions.

As we conducted investigations against the *Cartel de los Soles* and presented them, one after another to the US Department of Justice, we noticed and pursued leads from the Cartel's money-laundering operations to the world of non-governmental organizations and election companies.

After witnessing election irregularities associated with the 2020 US Presidential Election, we decided to direct time and resources to *Cartel de los Soles* links to US and global election fraud.

After an exhaustive three-and-a-half-year investigation, it is indisputable: [Smartmatic](#) Election Systems was created at the direction of now-deceased Venezuelan dictator Hugo Chavez, and its source code, the basis of its operating system developed jointly by Venezuela's *Consejo Nacional Electoral* (CNE) and Smartmatic, was designed to allow election results to be altered without the knowledge of voters and the public.

Additionally, the Venezuelan CNE holds ownership of Smartmatic's source code. Each time the Venezuelan CNE and Smartmatic update the source code, a copy of it is stored at the vault at the Venezuelan Central Bank.

In 2005, the European Union Electoral Observation Mission to Venezuela published a report, stating the Venezuelan regime owns Smartmatic's source code. The Venezuelan government signed that report as factual.

Smartmatic's first election in Venezuela was the 2003 Recall Election of Hugo Chavez. The CNE director at the time, Jorge Rodriguez, at the direction of the Cuban Directorate General of Intelligence, DGI, hired three Venezuelan-American computer engineers that were graduates of Simon Bolivar University, a Venezuelan university linked to the US University, MIT.

They had already registered a software company in Delaware and opened an office for it, in Boca Raton. The engineers, [Antonio Mugica](#), [Roger Piñate](#), and [Alfredo Anzola](#), established Smartmatic at the direction of the Venezuelan regime, built the source code, and flew off to Italy to buy lottery machines from Olivetti to serve as election hardware. **They succeeded in altering-up votes to ensure Hugo Chavez's victory in the recall election.**

Secure in power, President Chavez decided to weaponize this capability beyond Venezuela's border. Smartmatic would enter into the US election market in Cook County, Illinois [aka Chicago] and the state of New Jersey for Democratic Party Primary races in 2006.

In 2005, Smartmatic orchestrated the purchase of Sequoia Voting Systems Inc, a US company. Sequoia was a company that had conducted elections in the US for over 100 years and had a 22% market share of the US electoral market.

Approximately 18 months later, the Committee on Foreign Investments in the United States, CFIUS, began investigating the ownership of Smartmatic, because of Smartmatic's Venezuelan connection.

Smartmatic immediately put its source code in the machines, in the Sequoia machines. Smartmatic tried to conceal its Venezuelan connection by hiring a former [US Naval Officer, Jack Blaine](#), to set up a holding company, SVS Holding, to place its ownership of Sequoia in stock.

In December 2006, Smartmatic entered into an agreement with CFIUS to sell Sequoia in six months.

Antonio Mugica, one of the three original founders, then found a little-known election company in Toronto, Canada, Dominion Election Systems, that had only managed one small local election in Toronto. He arranged for Dominion to purchase Sequoia. Dominion, owned by [John Poulos](#), with that purchase of Sequoia would inherit the licensing agreement for Smartmatic's source code, the source code owned by the Venezuelan regime, i.e., the *Cartel de los Soles*.

To be clear, Smartmatic and Dominion would ultimately sign an agreement that provided Dominion with the US market and Smartmatic with the international global market. The only two exceptions are that Smartmatic does elections in Los Angeles County and Puerto Rico. Puerto Rico was an issue they ultimately settled in court.

In Caracas, in a building owned by the CNE, the *Concejo Nacional Electoral*, more than 100 software engineers, half in the CNE and half in Smartmatic, worked side-by-side. Their effort for more than a decade was to perfect the techniques of altering elections and defeating audit.

In 2018, Smartmatic publicly, and with the approval of the Venezuelan regime, broke with the regime, the *Cartel de los Soles*, because the Venezuelan CNE's theft of an election was so egregious.

The techniques of the source code and machine operate and conceal a theft of an election when the spread of the candidates is between three to five percentage points.

As sophisticated as the machine is, it can be defeated with significant turnout against it. The recent 2024 election in Venezuela was also so blatantly stolen and the machine could not conceal that massive spread, either.

In its place, a company called Xclay [?] took Smartmatic's place as the election provider in Venezuela. Allowing Smartmatic to exit Venezuela in this fictitious manner allowed the regime to retain its power and influence over the global electoral market.

Smartmatic built a production facility for electronic voting equipment hardware just outside Beijing, China, and then shipped the hardware to a warehouse in Taiwan. In violation of US Law, the hardware was marked as "Manufactured in Taiwan" and shipped to both Smartmatic and Dominion, for use in US elections.

Dominion Voting Systems manages elections in almost all the Swing States in the US, which determines who wins the Presidency. We have evidence and witnesses that can prove the source code operating the election machines of both Smartmatic and Dominion and other election companies are owned by the Venezuelan NARPA regime.

We have evidence and witnesses proving the machines are manufactured in the People's Republic of China.

Every citizen needs to be asking, "Where is the DOJ, FBI, CISA, and where is the CIA? Is anyone in the national security apparatus defending our democracy or enforcing the law?"

And if that isn't enough to convince you there's a major problem, Dominion, in an additional step to conceal its manipulation of US elections, moved its research and development and servers, which store Swing State voting information, to its office in Belgrade, Serbia!

In the Belgrade office, Venezuelan, Chinese, and Serbian software engineers maintain system administrative status over Swing State elections and alter elections, as directed by the *Cartel de los Soles*, the Cuban DGI, and the Chinese CCP.

The facility and its personnel are protected by Serbia's counterintelligence service. Swing State voter information is saved on Huawei servers in Dominion's Belgrade office. These servers are linked to Huawei servers in Hong Kong, China.

For years, the US National Security apparatus has identified Huawei and its technology as a threat to US National Security.

The Cybersecurity and Infrastructure Security Agency, CISA, a component of the United States Department of Homeland Security, is responsible for cybersecurity and infrastructure, across all levels of government.

CISA has 3,100 employees and a \$2.9 billion budget. In 2020, when faced with calls to address election irregularities, CISA did a conference call with Smartmatic and Dominion, in order to better able to address the public's concerns and assure everyone that there had been "No irregularities".

Yes, it's shocking. CISA decided to consult the criminals in order to respond to the American public's outcry.

In August 2024, three current and former executives of Smartmatic were indicted in Florida, in connection with bribery during the 2016 election in the Philippines. Among those arrested executives is Roger Peñate, one of the three founders and current President of Smartmatic. Roger Peñate paid \$8.5 million in bail.

What the public will soon learn is that the bribery paid in the case was not to obtain a contract. The bribery was paid to alter election results.

We have the CNE source code, the source code employed by Smartmatic, Dominion, and others. We will surrender it to appropriate authorities.

Source code, like DNA, can easily be matched with other systems to prove that they are from the same family. In this particular case, it is a family of altering elections.

Two years ago, we briefed a senior FBI agent in Washington, DC. That agent, after seeing our three-hour presentation with corporate ownership documents, engineering specifications, and witness statements, told us to flee Washington, DC, that the FBI would actively work to destroy our efforts and seek ways to prosecute us, in order to stop our investigative efforts. That was a stunning moment, hearing those words from a 20-year veteran of the FBI.

Seven months ago, with our attorney, we briefed a US Attorney and two Assistant US Attorneys, Federal Prosecutors from the Department of Justice. The US Attorney told us he would forward the information to the Office of Public Integrity at the Department of Justice.

That US Attorney followed up with us months later, to see if the Office of Public Integrity had contacted us. They never did.

Smartmatic, Dominion, and their media allies will immediately point to the fact that [FoxNews settled with Dominion, paying US\\$787.5 million](#), and that Newsmax just settled with Smartmatic, this past week in a defamation case as "evidence of Smartmatic and Dominion innocence".

In FoxNews' case against Dominion, we briefed Fox News trial attorneys. Our lawyers were present when we did that. FoxNews corporate officers refused to be briefed directly for that case. They wanted plausible deniability.

FoxNews corporate knew we had significant evidence – and, more importantly, witnesses. When all the facts are known, Fox News executives and Board will have to explain why they went down on their knees for enemies of the US.

We briefed Newsmax's corporate attorney, as well. Though their settlement with Smartmatic is not public, any settlement with either company and their masters, the *Cartel de los Soles*, the Cuban DGI, and CCP, makes it more difficult for those of us trying to defend the country and our democracy.

I ask everyone to go to the website [StolenElectionsFacts.com](#). Here, you will find articles and original source documents supporting the claim that Smartmatic and Dominion are employing a source code created and owned by the Venezuelan Regime, with hardware manufactured in China that alters election results.

I will follow with other videos and statements to inform and educate others.

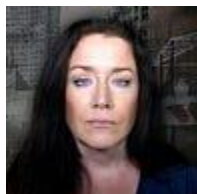

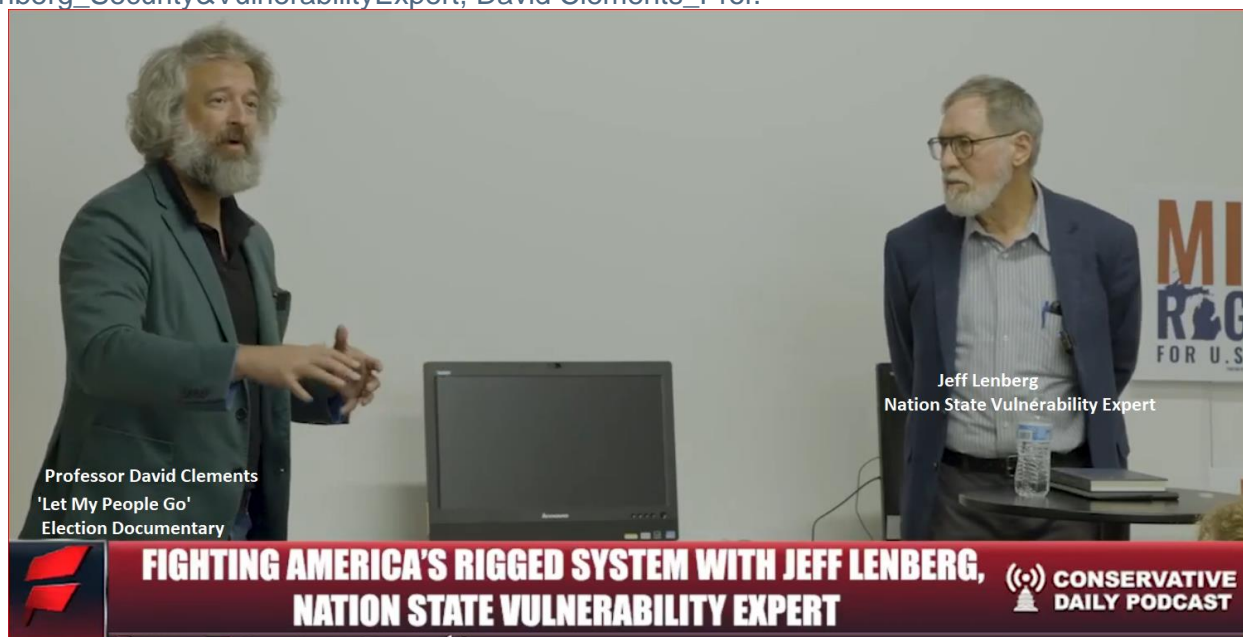

Well before you do that, including **Mary Kelly**, I think, for the folks that aren't quite as in the weeds as we are on the elections, **if there are three observations that are Michigan centric**, that because I know there's more than that, because you've filed reports, if they're over the past two years, you've had more time to reflect upon your time in Michigan. **What are three things that are Michigan related that you think are important to share with them?** And then perhaps we'll open it up to Q and A in the second half.

Okay, that sounds good, so I'll do the a couple lesser ones, and then do the **Mary Kelly** is the third one, because that takes a little bit more explanation, but, but, you know, the surprise for me in looking at the election system underneath the hood was, again, I was just trying to decide, is it compromised or not? Is there

anything that looks funny or not? The problem I had is everything I looked at was compromised, and I had such a long list, I told the local folks. I said, I need 50 people to help me look at this. I need a team. I need to. I was used to working with teams, and I would assign different teams things to look at. I needed a whole team. Well, I couldn't get it, so I had to look at certain things. So, for example, **[#1 of 3] the MODEMS**, you know, we've been told over and over, they don't have connectivity. Well, guys, I took pictures of modems embedded in ES&S machines that were not certified, that were not declared okay, that they told us they didn't use, and they were there. Not only were they there, when I printed out the system log for the 2020 election from the ES&S machine, it said, modem initialized. After they closed the polls, modem initialized. This file has just been transferred. Here's the file name, here's how long it took, the date and time of the transfer of the results over a cell phone modem to supposedly, the county. Okay, do you see a problem with this? Guys? Cell phone modems are two ways. All right, it works both ways. They communicate back and forth, not just one way. All right, when I would go to Africa, I've got a small business in Kenya, I would go down with a hot spot, I'd spend one or \$2 on a SIM card, plug it in, look online, the name of the vendor down there, Safaricom. I'd buy a Safaricom SIM card. The password for their network is online. I just put in the **APN [Access Point Name] name**, I put in the password, and I can connect with any phone number on the entire Safaricom network, which extends not just in Africa, but they have extensions that go on to various places in the world. **Well, that's what's inside of your tabulators, ES&S tabulators in a good chunk of your counties in Michigan, is a cell phone modem, and we found the APN name.** I'm not going to give it to you, but we found the APN name. All we needed was the password. Who has the password? **Ask your county clerks, they'll have no idea what you're talking about.** They don't have the password. **Who has the password? The voting machine company, their security**, I can tell you, is so crappy. Everything I looked at was crappy. I mean, when they have a tech technician, **password of, 123456**, how well do you think they're protecting the password to that cell phone modem? If I can get that password as a bad guy, I could be connecting to any tabulator that ES&S has with a cell phone modem in it from anywhere in the world. Why would you ever do that in an election piece of equipment? You would never, ever, ever do that. So when I say the architecture is compromised, the idea of cell phone modems in election system is insanity. Worse than that is those tabulators all talk to a listener at the county it's got a cell phone modem hooked to the same network, okay, the local near Verizon, or AT&T or whatever, that guy also, all you need is that same APN name and the password. Here's the problem, that thing's hooked to the EMS **[Election Management System]** through a firewall. Okay? The point is, if I can connect to that network, which I can anywhere in the world, if I can get that password, I'm now on that listener, which is now connected to that EMS **[Election Management System]** and their stuff is so poorly done that I guarantee you a nation state will be right through that firewall and do anything they want to that election management system. They can change the results. They can do anything they want. They can do it.

Quick, quick comment / insight that I'd like to get your take on. Have you all seen the **T shirts** that people are wearing in the Georgia hearings. It's like DBS Corp. Basically. It's an administrative **password to access the Dominion machines** that has never been changed. It's still that password right now, so they are openly mocking the Dominion officials by showing up saying, Folks, if you want to be able to do and subvert these systems, they're showing up with, with the password. Oh, wait, yes, exactly how long this passwords been out there. So, so the ability that Jeff's talking about, **it's not just relegated to Michigan, but it's happening in Georgia.** And I think there was some other thing that you raised that I wanted to ask you about. Oh, yeah, here's, here's a thought. See, right now, Jeff just talked about the idea of nation state. You call it advanced persistent threat level players. And I, you know, everything that I've learned from Jeff and others, it's so easy to reach these systems, but it presents a thought in probably your minds right now that you're thinking of some foreign adversary, okay, China, Korea and all that's possible, I've come to the conclusion, and Jeff knows how I feel about this, but I want you to give your thoughts on this, that breaching a firewall, I think is the wrong way to think about how the American system is being subverted, because as we research the architecture, **The Department of Homeland Security has basically created the system, which means they don't have to breach the firewall. They actually live behind it already.** And so just as you're sitting there, I don't want you to think about exclusive, this idea that some, some guy that's wearing a communist uniforms, typing on a keyboard and flipping votes, it's it's actually worse than that, because if your government hates you and they hate Maga, all of the protections that they're telling you about don't apply to the deep state. So they've got the

integrated software that's internet connected, where they can monitor data real time, from voter rolls to election night reporting, and that also means they've got the ability to adjust that. So thoughts on that? Jeff?

Yeah, what he's saying is absolutely true, and I'll add to that, that password that you mentioned is an administrative password to go into the Dominion software through the Dominion interface. You don't even need that. Okay? Why? Because in the States, we looked at Michigan on the forensic images, we know they were there. They have the database software which is not certified, not announced by the voting machine companies, not certified. It's sitting on their SQL Management Server tool, 17 or whatever, and it's got no password. In Michigan, in New Mexico, in Maricopa, it's on all of the machines, and there is no password. You literally click on the icon for that tool, which doesn't belong on there. It's not required to run the election. It's not certified, and you're in the database. And the Dominion system is driven by the database. It's database driven system. Everything's in the database. The configuration files are in there. The results are in there. Everything is in there. Okay, every vote is in there. All right, it's all in there, the ballots, everything is in there, no password, and you can go in once you get on the system, just on the Windows system, which we showed, had been externally accessed in Antrim, okay, without with a user, anonymous user, without any credentials, had accessed it all right? So you can go right in and do anything you want. You can grab the keys the Georgia case right now that they're talking about. There's a Georgia case that was brought about. Hey, the keys are required by, you know, HAVA [Help America Vote Act] to be protected, and they're not being protected. Yeah, they're not being protected. How do you think we modified the encrypted election files? Right? Our team grabbed the keys, and in four hours, they had the decryption done on the election files. In a day and a half, they gave me a tool so that I could decrypt it. I'd go in, I'd modify the files, I'd re-encrypt it, rehash it, feed it to the tabulator, and it said, looks good to me. I'll rent it. No problem here with the modifications that I put in it. Okay?

And to be clear, for folks that might not know what he's talking about, you saw in the film [Let My People Go Documentary] The demonstration where he's feeding the tabulator with a ballot for Joe Jorgensen, ballots for Biden, Biden, two for Biden four for Trump. And when they printed out the tabulator tapes and compared that to the EMS [Election Management System] system, those matched, even though there was a subversion that he that he programmed into it. And so the idea of the demonstration is everything that he's talking about. You can program and run whatever scripts you want to achieve whatever goal you want.

Yeah, yeah, absolutely. So this actually, I'm going to transition to number two [#2 of 3]. You said three. So number two, biggest thing, one is the fact that they've got all this **CONNECTIVITY TO THE SYSTEM THAT JUST DOESN'T BELONG IN THE ARCHITECTURE**. Okay? They've got, oh, this is B of the first one, and that is the fact that the equipment, the Dell computers that they use for the EMS [Election Management System] and that they use for the **high speed scanners**, and a lot of your counties don't use them, but some of them do use them. **They have Wi Fi and Bluetooth on the motherboard**. Okay, so I'll just say, in coffee County, the reason they came after us is that that system on election night Dominion went in, reconfigured, remotely reconfigured, that equipment without touching it. You know, the one they testified have no ability to do anything connect to it in any way. That's the one that they went in and modified. That's why we had a professional team come down investigate it. What Misty Hampton did in coffee County was absolutely correct. She saw something happen on her system that can't possibly happen. So she brought in professional forensics people to image it the software, and she brought in myself and others to do testing of it because of what they saw, because the system was breached on election night. So then they turn around and create a narrative to in the Curling Case and so on that we breached the system. That we're the breachers. That's why they tried to indict me in Fulton County in Georgia, claiming we breached the system when we were there investigating a breach of the system. And one reason they went after coffee County, this is a big deal, the fact that they have told everybody that they can't do what they did in the middle of an election, they modified that election. Now, whether they thought they had the right to do that because the election super supervisor said, fix my equipment doesn't matter. They told all of us they didn't have that. That's a feature they didn't declare. That's a feature that was not certified. That's a feature that they testified didn't exist, and yet it does. The problem is not that I think Dominion's going to go in and modify the election, but if Dominion can get in, and I'm a nation state

bad actor, it's all over. Because there's a path in there and I'm going to get in, you're not going to stop me from getting in. It doesn't belong there. Ultimately, yes, the county burns that USB stick or that SD card or that compact flash card that goes in the tabulator most often. But they didn't create **that election file. It was created by a third party that works for the voting machine company.** They might not even be in your state, and they created that election file. Now, do I think the guy creating the election file was bad? No. What are they doing? They're using a single software package called **ELECTIONS.**

One comment, because you guys have to be cognizant of this, many of your clerks will tell you that they have custom, **custom software** that they develop in house. **It's not true.** So there's got to be a root source of basically the files that Jeff's talking about. And what usually happens is, depending on what they pay for, on things that are part of a suite of products. It's given a fancy name, but it's basically the same program. And so when they tell you that, it's almost a lull, you into a sense that, oh, wait a minute, you you're generating this. You're doing none of them have the technical capabilities to do that number one. But, you know, so in our in New Mexico, it's service. I think it's still, it's basically the total vote package, but we call it service, total votes, used in Arizona, but it's called something else. So watch out for the trap where someone says, Well, you don't have to worry about that is actually generate the file. It starts from the vendor, right?

Yeah, it starts from the vendor. Each vendor, each of the major vendors, has something. **Dominion** calls **Election Designer**. Okay, so those people who say, oh, well, we program our own elections, right? Louisiana says that too. Secretary of State says, look, it's safe because we program our own elections. Most of you guys in **Michigan** do not program your own elections. Your county does, okay, that's good. What's that? Okay, but let me tell you what they're doing when they say they program it locally, even though most of you in **Michigan** don't, because I see that in a log file **Dominion**, you know, 18 different counties or something like that, one of the expert witness reports all programmed by the same vendor that programmed **Antrim**. All right, but they have an Election Designer package. So when they say they program it, all they mean is, we didn't hire a third party to put our race, our candidates and our races in. We put it in ourselves into the **Election Designer Software**. **Hart** calls it something else, but it's the same kind of tool. So they put in all of the races, all of the candidates, all right, then what do they do? Once they got all that checked out, they push a button and it says, generate the election. And it runs 1000s of lines of code. It runs 10s of scripts, if not hundreds of scripts. The people running that software have absolutely no clue what is happening, none at all. Okay, they didn't program those election files. They put basically all the race information into the system, and then they push a button, and the system does lots of stuff. I've seen it. I've seen it myself in the log. Fit this, this, this, this, it generates hundreds of lines, and in the process, at the end, it wraps it in encryption, and it has a file for you for every tabulator, okay, for every ballot style, every calculator or whatever, it's got the file generated and it's encrypted, which means, great thing, it's secure. No one can change it, right? Well, unless you're a guy like me, okay, I can change it, but supposedly no one can change but you know what? No one else, no one can look at it. You don't know what's in that file. So as a bad guy, what I'm going to do is subvert that **Election Designer Software** when it's running those 10s of scripts. I'm just going to put a slight modification in one of those scripts, and the guy or gal that pushes the button has no clue to what I did, all I need to do, is get on to their system somewhere in the supply chain for that software, and usually they update that, because there are vendors that do this kind of thing, even here, I'll bet you at least once a year, **Hart** updates that package Right, if nothing else, they require you to put on the security updates. What's that? There's an update coming in March. Okay, they come in and I gotta tell you, you have no idea, none at all, when you the tech doesn't know, when the tech comes in and plugs it in and says, I'm running some updates on your system. They don't know what they're doing. They plug it in, and it auto starts, or they give it a command to start it, and then it runs a bunch of stuff they didn't develop that they have no idea what it's doing. It could be doing anything to your

computer. Guys, this is true of every vulnerability download that you get from Microsoft Windows or from a phone or an Android form phone, and they claim, hey, you got to do this because we have security vulnerability patches, right? And then they argue, oh, you didn't do your vulnerability patches updates, so your system is not secure. I'm saying it doesn't matter if you do it or not, because no one knows what's in that patch. I can tell you you have no idea, and the people that made that patch have no idea. Do you understand what I'm saying? Because there's a supply chain, and in the supply chain, a bad guy can do something to that so that they don't know the guys that created it don't know what's in that patch ...

... Which forces otherwise good people into the need to defend their actions and their clerk office actions and the IT person. So the subversion so elegant because **it's so upstream** that that you've got people that are really defensive, and it not only is for no one hearing from you up Jeff, is that **you can basically infect all of the tabulators and from a Single Point**, single point, okay? And the other thing that want to highlight with this is that this also means that **internet capability is really not as important**. It's important, but everyone gets caught up on whether you've got modems. **If you subvert that single point**, you can have a hardened, closed system architecture, have the tabulator behind closed, locked doors, have someone with a gun, and there doesn't need to be a hack, because the manipulation of the hardware has basically been placed. **It's almost like the clerk is loading their murder weapon and not knowing.**

Exactly, that's what I'm trying to say. The architecture is such guys, and this is related **to the myth of the air gap**, right? That's the big defense they have in Louisiana, is **the air gap**. So, in fact, I got to tell you, so I was just in the courtroom down there, right? And for this, this case, and they're arguing over the first exception or whatever. And the defense attorney, this woman for the state of Secretary, a very well known, good attorney, I'm told, but works for the Secretary of State and is doing what she's told to do. So she was trying to argue about how great their security was, and her number one point **was the air gap**. And when she said **air gap**, we had 40 or 50 people on our side of the courtroom, and simultaneously, unplanned, **40 to 50 people let out a belly laugh so loud** that the bailiff had this courtroom because **we erupted with laughing**. No one planned it. Just simultaneously, everybody knew that the air gap was a myth, and so the judge was taken aback, the defense attorney was taken aback. But that's their story that they propagated, that everybody's supposed to believe.

No, it's definitely due to that. I mean, they were so well educated that group about **the air gap** that everybody simultaneously, it was loud, was laughing at their defense, and that was their main defense was the air gap. And I'm going, they're clueless. They're clueless if that's their main defense is **the air gap, because the air gap is a myth**. And here's why it's a myth, very simply, I have some **USB sticks** in my pocket. So they use a **USB stick** or a **SD card** or a **compact flash card**, depending on where you're at, right? And so what do they do? **They program it**, they bring it over, and they plug it into the machine, and they do their **LAT [Logic & Accuracy Test] tests** and so on, and then they run an election, and then you take the results back and plug it into back into the **EMS [Election Management System] machine**. Usually, that's where they burned it. Sometimes it's burned on a different machine, but that's okay. So it goes back and forth, right? And they're saying it's air gapped because we don't hardwire to our tabulator, and we don't turn on the Wi Fi in our tabulator, and we don't use the Bluetooth. All of these things, by the way, are in their ICX machines. There's WiFi. It's an Android tablet. Is the basis of the **Dominion ICX** that they use there. **So it has WiFi, it has Bluetooth.** We don't hook that up. And by the way, it's also going to hardwire connection. We don't hook that

up either. And I believe them, they don't hook any of that stuff up, so we have an air gap. But what is this? I mean, a wire just transfers bits back and forth at a high speed, because it's a wire, a Wi Fi or Bluetooth does it a little bit slower, because it's got to go up through some mechanism, usually a modem or cell phone or, you know, tower or something, and then come back down to a server. It's a little bit slower. This is a two-way mechanism goes out and it comes back. It's just a lot slower. That's all it is. It's a matter of speed. **There is no air gap. This here [Thumb Drive] bridges the air gap. So the only way they'd have an air gap is they never put anything in the machine.** If they never stick anything in the machine, then I might believe they have an air gap, and all the other stuff is disabled and never connected. But that's not what anybody does. **Every one of them programs that machine with something and then takes results away and plugs it in. Back in 1995 one of the women says, do numbers speak to you?** That was what she asked. And they kind of do. So I'd been studying it. I had already looked at like the candidate numbering and the race numbering, and so I was familiar with the numbering, and I saw this number as I was decoding the election files, and it was all by itself, and I couldn't figure out what it was, why it was there, and it was showing up in all these files at the beginning of the file, and I decoded most of the files. Our team had decoded most of the files structure. And it was, by the way, it was binary. There was not a standard format. **It was just a binary format.** And it's something I do that I learned to do it in my work, the vulnerability work that I did. So I saw this number. Okay, well, what else is going on in the Supreme Court race?** And I started looking at that, and I had mapped out the files to where I could see the patterns for each candidate. So there were a bunch of, I don't want to get too technical, but there was a pattern that you would see. Here's candidate one stuff, candidate two stuff, candidate three stuff. Kind of like that for all of the candidates, okay, and they had associated files, basically pointers, memory, pointer kind of things. Is what it looked like **when I got to Mary Kelly. She didn't fit the pattern, and two other people out of the seven in that race didn't fit the pattern, and the two constitutional questions at the end didn't fit the pattern.**

What were the constitutions? Do you remember?

Jeff Lenberg_Security&VulnerabilityExpert 28:53

I don't remember. Do you know? But I just, I'm just wondering, does anybody remember from **2020** what your statewide constitutional questions work. Okay, well, they also had this different programming. So there's two things about it. One is, they didn't fit the pattern. Okay, they weren't correct in the pattern where they should have been. They were pointing somewhere else in memory, basically. And then secondly, there was an associated file with each one of these candidates, or whatever, and they had a pattern. **And I noticed for these ones that are different, they had extra bytes in them. So these associated files, for these people, and for the constitutional question, they had extra bytes. Now I couldn't figure out what the extra bytes did, but they had extra bites that didn't belong there. Okay, so these candidates were being treated differently. Who were they? Mary Kelly, Elizabeth Welch, who was the Democrat? Mary Kelly was the Republican. It was Elizabeth Welch [Democrat]. Welch and it was Schwartz or Schwartzel [Brock Swartzle – Republican].** Do you

remember Schwartz was Schwartzel? Yeah, so those three now that's a Republican, okay, he was Republican. **The one that won was, well, she was Democrat [Elizabeth Welch], and then Mary Kelly was Republican.** And then **I looked at statistics across your entire state**, in all the different counties, and what I discovered was something interesting, and that is, I know **judges are supposed to be nonpartisan** voting here, right? **But everybody knows who's a Democrat and he's a Republican, right?** But so what I did was I took the Democrats that were running and the Republicans that were running. And then there was a couple that were kind of independents in there. There was some others. But I added up basically the Republican votes. I added up the Democrat votes. Found was your counties, **you had people voting for the Republican candidates like Trump and your other Congress and senators, and they were a certain percentage. And what I found across your entire state was that for the Supreme Court race, there was this shift that occurred where if they got the same percentage that the main candidates got in the Supreme Court race, then the Republicans would have had 24% more votes. It was a big shift. In other words, you had Republican counties where your Republicans were voting more for the Democratic candidates than they were for the Republican candidates.**

And in 2020 that's hard to believe.

You see the problem. All right, so when **I looked at these three candidates**, to me, they did was they took a bunch of votes away from **Mary Kelly**, and they split the votes and gave them to **Swartzle**, and they gave them to **Welch**. They split them between those two. Well, what did that do? Well, **Swartzle** wasn't getting enough to win anything, so it just siphoned some of the votes away, but it gave **Welch** enough to get over the top of **Mary Kelly** by doing this across the entire state.

Now let me ask a question, because Joel [Jeff], you mentioned some of your observations with some races. **Aren't you finding that you've got lots of people that are showing up that have no ground going, no signage, and then miraculously, they're getting either siphoning huge amounts of votes out or outright winning. And so this gives you a hypothesis to work with.** If you want to look at this from a larger I guess, framework, I have to wonder that these guys, if they're this systematic and getting down to the bit and bite level to subvert things that they're **they know they can't overplay their hand and attack every race**, but this tells me that **there was a big, big emphasis on the court structure.** And when you just think of this as a **subversion** that you want to build upon, **you always want to create control over those vectors of either Investigation or Adjudication.** And **Michigan** is so screwed because of **Dana Nessel.** **So you've already got the strength of the Law, and all that was left was to make sure that your Judiciary at some point, even if you've got honest district court judges, remember they have to go through the appellate system.** So you might have a guy that's a great Republican judge has your values and he gives you a great ruling, they appeal it at some point, **it's going to get back to this next gatekeeper [the Michigan Supreme Court],** yeah? And, and that was the that might have been **the victory to basically close [the deal].** **The last place that you had some hope was the Judiciary, and that's done, yeah, which goes back to why I keep saying from the ground up, you've got to have people that could say no at a certification. Yeah.**

Yeah. So let me, let me add to that. First, I'll finish **the constitutional questions**, and then I'll take off.

? **Constitutional amendment, [Parks] oil and gas was one?** And then constitutional amendment **electronic data and communication, search, one.** Yeah.

? So one of those, **one of those was the one that Whitmer got.**

? elected 22 okay,

So anyway, if you look at those at the time, and **the oil and gas one was particularly interesting, it was basically going to take funds and make them available to someone over here that was not necessarily a good entity, that was kind of a left wing controlled entity. That's what it looked like in the woman getting that approved.** Now what happened in, in in Antrim, when I found this, it **affected the constitutional questions** also. But what happened in the modification that **caused the 7000 votes to be shifted out of 16,000** at the same time this shift caused that occur to occur? It also what happened was **the top vote in every race we shifted up one and was thrown away.** Okay, it should have been what's to say this? Let me first say what it did. It shifted it up one, and then the next thing down in the race, one. **And if there were more choices in the race, more candidates or whatever they were shifted up. But for the yes no questions, what happened was, then the yeses were thrown away, the NOS all became yeses, and there were zero nos.** So if you want to pass a constitutional question, this is a great way to do it on some percentage of the meat machines, just shift them all one, and all the NOS go away for that particular ballot style or race, and they become yeses. Great way to do it. Now, take off on what he was saying.

Okay, we're going to riff now. The reason why I want to riff on this is that **most of your challenges have to be brought by a candidate that has been harmed. So when you think about constitutional amendments, there's, there's no one that can challenge it.** So you can hijack your ballot. You can hijack property taxes. Yeah, you can hijack, I mean, you can basically your wallets, and **no one has even, even has the ability to challenge those provisions.**

Jeff Lenberg_Security&VulnerabilityExpert 37:02

Because you can't get standing Yeah. So as I gotta tell you, as a bad actor, which I played for 16 or 17 years, nation state actor, **if I was going to attack someone else's election, the first thing I would do is subvert the Supreme Court Justice races in the states and the Constitutional Questions,** that's where you start. Why? Because now you can get marijuana approved or some other thing you want to do to create **degrade the society or to steal money from them.** Then when it gets challenged, it's going to go to **the Supreme Court of the state, and they're going to uphold that nonsense.** That's where you start. So I believe **this subversion is actually a legacy subversion.** Keep in mind, this thing is so wide open that **nation states would be foolish to not have been subverting our system for years.** Okay? **The example I** like to give is it's so bad that it's **equivalent to taking a pallet of gold bars** from Fort Knox, putting it down in the middle of a New York City intersection **in the middle of the night and walking away.** How long do you think those gold bars would stay there? They'd be gone in a half hour, right as soon as people find out they were there, they'd all be grabbing as many as they could. They'd be gone. **Well, that's how this election system is so badly subverted across every aspect of it, not just the machines, but the registrations. We've seen it all. Okay? The whole system, the audits, everything is subverted.** If you're a nation state actor, that that's our adversary, they would be foolish to not have gone after our system. So there's likely the **biggest problem.** My little team in New Mexico, we used to joke about it early said, This is so bad, what we're seeing, that the biggest problem I would have as an attacker of our system is to make sure I don't trip over other subversions that had already been put in the system, that I wouldn't get tripped up by the other subversions in the system. So I think this **was probably likely an early subversion into the system was the [Michigan] Supreme Court.** It's probably a legacy subversion **Supreme Court races and constitutional questions, they definitely were programmed differently than all the other races.**

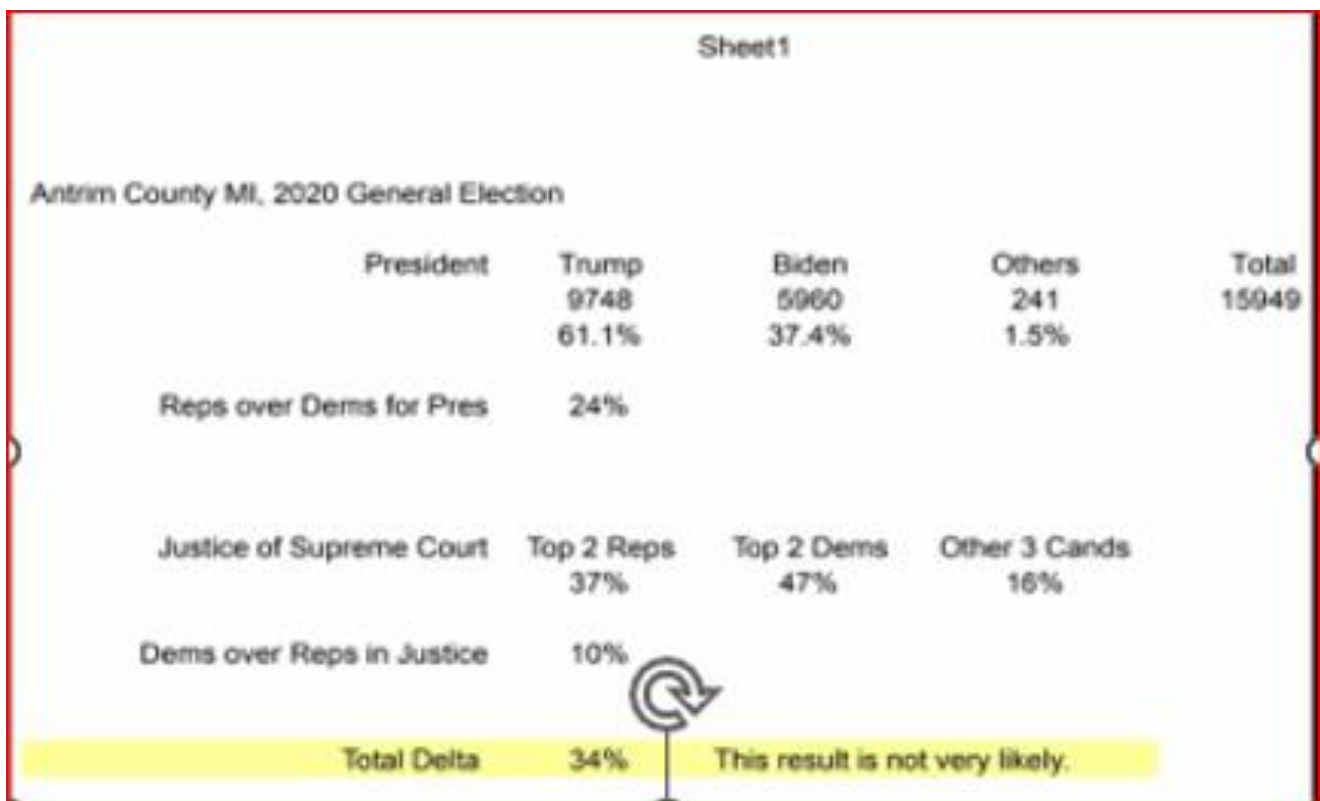

Okay, so at this this point, **I think we gave you just enough of Michigan to make this work** that hopefully showing up also. I promise that between Ken Beyer and myself, that if you've got serious inquiries, consider us part of your network, that we can go forward. So I don't want you to feel like, oh god, he's leaving, because your victories are our victories. More importantly, **when you have Rubber Meets Road court cases, Jeff, he's got an obligation and a responsibility to use what he's learned over his career to show up and provide**

solutions. And I know him well enough that if there is a real opportunity where we can investigate and not be thrown in jail, if it's not just being, if it's not just a setup, he will answer the call. So at this point, we're here and I'm learning even more. Just listen to you for tonight. But any questions?

Can, and before you do, can I make one additional comment? Sure. It won't be that long for those that when we talk about this stuff, the movie and so on, say, well, gee, if it's so bad. What are we going to do? You know, **how do we solve this?** And I just want to say for this election, until we can get this gutted, and we have to, no matter what, we can't stop after this election, because there's going to be a huge move. **So, let's say Trump wins, even on the conservative side, people are going to say, see, the system worked. We can keep it. No, we can't. Okay, it's got to go.** We got to fight until it's gone, all right? And it's replaced, so completely replaced. But how do we do that? Well, we're not telling people not to vote, just the opposite. Is the only way to overcome the system is to make sure we get everybody we can register to vote and get them out to vote, because if you don't, then the computer algorithms can vote for you. They need all those ballots that they stuff, all those ballots that they swap. They have to reflect that in the voter rolls. So if you don't vote, if people don't vote, and they're on the rolls, the computer algorithms can use them, and they need those people. They need a lot of people not voting, right? So we need to get everybody out to vote even more. So there we have evidence to believe that those people that was doing this was finding people who were eligible in your state, who were not registered to vote, and then the county clerks were supposed to try to get a hold of all those people and get them registered right? Well, we believe in New Mexico, they were automatically registering these people. So there may be people on the rolls that don't even know they're registered to vote that they can utilize, because they don't expect them to vote. So anything your organizations can do to get more neighbors, more people, everybody saying, Look, we need everybody to vote no matter what, no matter what the polls say, no matter what everybody is saying, We need as many people out to vote as possible. **Get registered if you haven't, you Drag your neighbors in to get registered get them to vote, so that their name and address, or their registration, cannot be used by a computer algorithm to cover the cheating that they're doing, and the more real votes we have in the system, the more they have to cheat to be able to overcome those.**
